THE PRIZE CURRENTLY CONSISTS OF STUDIO SPACE FOR ONE YEAR, A MONETARY CONTRIBUTION TOWARDS MATERIALS AND AN EXHIBITION FOR THE ARTIST CONCERNED TO SHOW THEIR WORK, AT THE END OF THE YEAR.
