At the end of the reporting period the charity had free reserves amounting to £3,704 (2021: £1,853).

In addition to the free reserves the charity has cash balances of £29,019 (2020: £10,494) and investment assets of £621,743 within the expendable endowment fund which can be released to support the activities of the charity.

The Trustees pursue a policy of maintaining a free reserve available to be spent in the furtherance of the charity's objectives, as well as covering future needs, opportunities, contingencies and risks.

C3 Related party transactions

No trustee received any remuneration nor reimbursed any expenses in the year under review.

During the period under review Coutts & Co, a trustee of the charity to April 2021, was paid fees for the provision of administration and investment management services amounting to £4,180 until retirement. Ludlow Trust Company Limited was appointed trustee in April 2021 and paid for administrative services totalling £2,973 from appointment to the end of the year. These fees are authorised under clause 6 of the trust deed.
