Activities

Objects: (1) THE RELIEF OF POVERTY AMONGST PERSONS RESIDENT OR WORKING IN GREATER LONDON AND IN PARTICULAR THE LONDON BOROUGHES OF NEWHAM, REDBRIDGE, HAVERING, BARKING AND DEGENHAM BY PROVIDING SUCH PERSONS WITH LEGAL SERVICES WHICH THEY COULD NOT OTHERWISE OBTAIN OR WHICH IT WOULD NOT BE REASONABLY PRACTICABLE OR APPROPRIATE TO OBTAIN ELSEWHERE.(2) THE ADVANCEMENT OF EDUCATION AMONGST PERSONS RESIDENT OR WORKING IN THE BENEFIT AREA (LONDON BOROUGHES OF NEWHAM, REDBRIDGE, HAVERING, BARKING AND DAGENHAM).(3) THE ADVANCEMENT OF SUCH OTHER CHARITABLE PURPOSES AS ARE BENEFICIAL TO THE COMMUNITY FOR PERSONS RESIDENT OR WORKING IN THE BENEFIT AREA (LONDON BOROUGHES OF NEWHAM, REDBRIDGE, HAVERING, BARKING AND DAGENHAM).

Activities: A) TO RELIEVE IMPECUNIOUS PERSONS, BY PROVIDING THEM WITH LEGAL FACILITIES PARTICULARLY IN CONNECTION WITH A POSSIBLE OR ACTUAL, CLAIM OR DEFENCE, BEFORE A TRIBUNAL IN GREATER LONDON, FOR WHICH THEY COULD NOT OTHERWISE OBTAIN, BY REASON OF THEIR IMPECUNIORITY. (B) PROMOTING WELFARE AND DEBT ASSISTANCE FOR THE POOR AND THOSE IN NEED. (C) SUCH OTHER CHARITABLE HELP FOR THE BENEFIT OF THE PUBLIC.
