**Activities:** To maintain and improve a network of care for sick and injured wildlife, and to care for and rehabilitate back to the wild. To give help and advice to members of the public concerning wildlife, by telephone, email, and post, and to raise awareness of their plight. To provide information to local schools concerning wildlife and hedgehogs.
