SVH Treasurers Report

1st January-31st December 2024

Summary

2024 was another strong year outperforming previous years, with both private hires and regular bookings increased on 2023 levels.

Regular hires have continued to provide the backbone of the use, accounting for over 80% of the revenue in the period. 2024 saw 2 new regular hirers use the Hall, both have been skillfully accommodated into the congested calendar by the bookings officer.

Private hires have increased around 20% from the previous year, stretching the available resources and leading to increased servicing costs in line with projections from 2022. Staffing has cost £690 in year.

In 2024 the hall cost £19,285 to run with servicing costs increasing to 65%, a 5% increase from 2023. As expected with the end of the fixed rate the Utility cost for the year increased by 3.5% to £4,018 in 2024.

The new Community Centre will see increased servicing costs with uncertain volumes of hires. While we have taken measures to ensure a healthy reserve, the uncertain costs and volume of hires make accurate projections challenging. We have made arrangements with the Parish Council to ensure financial support is available should it be required while the hall is established and a baseline of the facility is identified.
