Structure, Governance and Management

Governing document

Getting Court is governed by its Trust Deed / Constitution, under which the trustees are responsible for the general control and management of the administration of the charity.

Appointment of trustees

Trustees are appointed in accordance with the governing document. When new trustees are recruited, they are provided with information about the charity's purposes, activities, and governance, including recent trustee minutes and financial reports.

Trustee induction and training

New trustees will receive an induction covering their legal responsibilities, the charity's financial position, and current projects. Ongoing training is encouraged where relevant.

Objectives and Activities

Charitable purposes

The charity's objects are to advance and support education for young people to learn about the justice system.

Public benefit

The trustees confirm that they have complied with the duty in section 17 of the Charities Act 2011 to have due regard to the Charity Commission's guidance on public benefit.

The charity's activities during the year were carried out to further its charitable purposes for the public benefit.

Activities during the year

During the year, Getting Court focused on:

- Arranging and supporting visits by young people to the Crown Court and magistrates court in Oxford.
 - Arranging and supporting visits by young people to Huntercombe Prison.
 - Arranging and supporting visits by prisoners under supervision and on ROTL to schools.
 - Developing research and impact reporting to demonstrate the effectiveness of the charity's work.
 - Maintaining and improving the charity's website and communications to increase awareness and outreach.

Achievements and Performance

The trustees are pleased to report continued growth in donations and supporter engagement during the year. The charity successfully transferred capital from the OCF to strengthen its financial position and enable continued delivery of its services. Research and impact reporting activities helped to evidence outcomes and inform future planning.

Reserves policy

The charity's principal sources of income during the year were donations and dividends, alongside a transfer of capital from OCF.

Financial position

The trustees consider the charity to be in a stable financial position at the end of the year, with sufficient funds held to meet current and planned commitments.

The trustees have assessed the major risks to which the charity is exposed and are satisfied that systems and procedures are in place to mitigate exposure to these risks. Key risks include reliance on voluntary donations and compliance with regulatory and governance requirements.

In the coming year, the trustees plan to:

- Expand outreach and awareness activities.
- Continue developing impact reporting.

- Explore additional funding opportunities to support sustainability and growth.




