TRUSTEES' REPORT
FOR THE YEAR ENDED 31 DECEMBER 2024

The Trustees present their report and the unaudited financial statements of the charity for the year ended 31 December 2024. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

Since the company qualifies as small under section 383, the strategic report required of medium and large companies under The Companies Act 2006 (Strategic Report and Director's Report) Regulations 2013 is not required.

The Link Foundation is a voluntarily staffed children's charity based in Maidenhead that is committed to improving the lives of children and their families in the local community and surrounding areas.

Objectives and activities

a. Policies and objectives

In setting objectives and planning for activities, the Trustees have given due consideration to general guidance published by the Charity Commission relating to public benefit, including the guidance 'Public benefit: running a charity (PB2)'.

The Link Foundation aims to help as many disadvantaged children as possible in Maidenhead, Slough, Windsor, Ascot, Bracknell, Marlow, Aylesbury and Wycombe. Working with their strategic partners, the charity identifies families who are struggling to provide essentials for their children. The charity is always reaching out to new groups so they can endeavor to help as many children as possible, and the trustees regularly meet with health visitors and schools to educate them on how the Link Foundation can help their families.

b. Strategies for achieving objectives

The year 2024 remained incredibly challenging for countless families in our community. The lingering effects of the Covid-19 pandemic continued to take a toll, particularly on those in low-income or zero-hour contract jobs, many of whom lost their employment. Combined with the ongoing cost of living crisis, this has pushed more families than ever into hardship.

Many who had never needed help before found themselves turning to The Link Foundation, applying for vouchers for essentials like food, clothing, and hygiene products as they fought to make ends meet.

At The Link Foundation, our mission is to step in during these times of crisis by providing grants that meet the specific needs of local children.

We support children in a wide range of difficult circumstances, regardless of background, race, or religion, when we know our help can make a real, lasting difference. This includes:

- Children living with a disability
- Children affected by parental illness or abandonment
- Children living in domestic violence refuges
- Children whose families simply cannot afford the basic items or small, everyday comforts that every child deserves.

Every year, we are proud to support hundreds of local children and their families.

What sets The Link Foundation apart is how closely we work with trusted community professionals, those who are embedded in the lives of the families we aim to help. Our referral partners include:

- Health Visitors
- Family Nurses

These professionals are in a unique position to identify children in genuine need—especially those from families who may not feel comfortable asking for help. We only accept applications submitted by these partners, using our official application form to confirm their support.

Because our entire team is made up of volunteers, we do not have the capacity to visit and verify every application ourselves. That's why the input and endorsement of our referral partners is absolutely essential.

Our low overheads also mean that 93% of every pound raised goes directly to helping children and their families.

At The Link Foundation, we truly believe that even a small gesture can make a big difference in a child's life.

c. Fundraising practices

Since its inception in 2006, the Link Foundation has held annual events to raise funds for the charity. This included Fireworks and Fun, Let's Rock the Moor and the Link Ball.

Since 2022, and mainly as the result of the pandemic, the Link Foundation has moved away from major fundraising events and has actively pursued grant applications to other foundations and trusts coupled with a drive to engage businesses and their corporate responsibility programs. It is hoped that in 2025 the charity will recruit new businesses to help fundraise for the charity.

In 2024, the Link Foundation received donations from other trusts including the Louis Baylis Trust, St James Place, the Berkshire Community Foundation, Heart of Bucks, MCS Rentals, The Green Hall Foundation and the Louis Baylis Trust and the trustees are incredibly grateful for this support.

The Link Foundation does not approach the public for donations unless it is as part of a wider fundraising events such as the Maidenhead Boundary Walk so protection of the public does not apply to the charity.

The Link Foundation plans any fundraising events a year in advance, and our standards of fundraising are rigorously adhered to by the trustees.

d. Main activities undertaken to further the company's purposes for the public benefit

The Link Foundation is committed to making a meaningful difference in children's lives by providing grants that meet both urgent and long-term needs. This support can include essentials like vouchers for school uniforms or shoes, funding for vital household items, or specialist equipment to ensure children with disabilities are more comfortable at home. We also help cover costs for school trips or short breaks, ensuring all children can enjoy enriching experiences alongside their peers.

In addition, we sometimes assist local families by distributing high-quality, nearly-new donations of children's clothing, toys, and baby equipment.

In 2024, the Link Foundation continued to respond to the ongoing challenges left in the wake of the Covid-19 pandemic, alongside the deepening cost of living crisis. With local community services severely impacted and many families already under financial strain, increasing numbers found themselves pushed further into poverty.

Our support has remained vital in helping them navigate these difficult times.

2024 Highlights from The Link Foundation

In 2024, The Link Foundation was once again fortunate to receive generous support from a number of valued donors. A major contribution came from the MCS Foundation, which donated £12,000 — marking the fifth consecutive year of their support for vulnerable local families.

Other significant donations included:

- £15,000 from the Berkshire Community Foundation
- £10,000 from Heart of Buckinghamshire
- £4,500 from the Shanly Foundation
- An incredible £16,000 from Timbertown Charity in Maidenhead
- £10,000 from the Green Hall Foundation
- Additional appreciated support from the Louis Baylis Trust and The Prince Philip Trust

Community fundraising efforts also played a key role, with nearly £4,000 raised by Maidenhead Athletics Club, and £5,000 contributed from the final Let's Rock the Moor event — which has proudly supported the Link Foundation since 2011.

Supporting Young Mothers through the Family Nurse Partnership

In 2024, The Link Foundation continued its important partnership with the Family Nurse Partnership at Wycombe General Hospital, which supports very young mothers facing financial hardship. Through this collaboration, the charity provided essential items such as cots, prams, and beds, helping these mothers create safe and supportive environments for their children. Feedback from the Family Nurse Partnership was overwhelmingly positive, with the team noting the significant impact on the mothers' self-esteem and their ability to care for their babies.

Christmas Giving 2024

During the 2024 Christmas season, The Link Foundation worked with 20 local children's centres and schools to provide gifts and meals to disadvantaged families.

Generous support included:

- Hundreds of Christmas presents donated by the Stoke Park Club, Lapland UK, St Piran's School, and Record Currency Management
- The Beauty Bank, which contributed toiletries and makeup for teenagers
- £1,000 from Berkshire Community Foundation to help fund festive meals

With additional contributions from the Louis Baylis Trust and the Englefield Trust, the Link Foundation distributed Christmas dinners to over 600 families. Each family, referred by local health visitors, received a £25 Sainsbury's voucher, helping to ensure a joyful holiday season.

Strategic Partnerships and Community Support

The Link Foundation works closely with a network of local charities to reach the most vulnerable families.

Regular referrals come from organizations such as:

- Homestart
- Family Friends
- DASH
- Hestia
- Abri
- RBWM Social Services
- Health visitors and social workers in Wycombe

In 2024, the charity also received a growing number of applications from Slough Borough Council and Slough Children's First, highlighting the strength of these partnerships. Additionally, invitations for support were extended to:

- The Achieving for Children health visiting team in Windsor and Maidenhead
- Children's centres and health visitors in Bracknell and Bracknell Forest Council

The trustees of The Link Foundation aim to visit strategic partners each year to review the charity's impact and improve the services offered. Although in-person visits have been limited due to increased remote working post-pandemic, trustees remain committed to resuming face-to-face engagement in 2025.

Achievements and performance

a. Main achievements of the company

In 2024 the Link Foundation worked with the health visiting teams in Maidenhead, Slough, Bracknell, Windsor, Reading, Wycombe, Aylesbury and Marlow as well as local schools to identify families that were finding life incredibly difficult. The Link Foundation helps families by donating vouchers, for the appropriate shop which can be given quickly to families in need, and, in some cases, health visitors asked for urgent help for families and the charity gave emergency help in the form of vouchers that were picked up directly from the office.

The Link Foundation relies on the continuing flow of donations to fund its grant giving activity and this was never truer than in 2024.

The Link Foundation received several generous donations both personally and from businesses, including the following personal donations - £1,000 from Jane Loughrey and some smaller donations from other local families.

The Charity also had some sizeable donations from local businesses and foundations. The Berkshire Community Foundation donated £15,000, Lets Rock the Moor raised £5,000 (accrued in 2023), Louis Baylis Trust £4,500, MCS Foundation donated £12,000, Maidenhead Athletics Club donated £4,000 and 52 Lives donated £1,000 to help with the Link Foundation Christmas appeal.

Nicola Ross was recruited as a trustee in 2020 and her remit has been to create a presence for the Link Foundation on various social media platforms. Nicola is a great asset to the charity and her work continued and expanded throughout 2023 and the difference she has made with fundraising is indicated by the increase of money donated via JustGiving, which is a direct response from social media campaigns on LinkedIn, Facebook, Instagram and Twitter and this will continue throughout 2025. Nicola has also taken on the role of gatekeeper for the Link Foundation website, which is another key element in our charity fundraising campaigns.

At the end of 2024 the trustees agreed that, until 2028, the Link Foundation would not support international charities as the demand on funds from local families living in poverty has increased over the last five years so all money raised should be used in the community. This will be reviewed in 2028.

b. Key performance indicators

The Foundation aims to keep reserves at a minimum by distributing funds directly to children and their families. In the year to December 2024, 93% of expenditure is related to assistance and direct costs of raising voluntary income.

Financial review

a. Going concern

After making appropriate enquiries, the board of trustees has a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. For this reason, it continues to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Statement of Accounting Policies.

b. Reserves policy

The work of the trustees generated total incoming resources of £113,078 (2023: £110,402) which is an increase of 2% from the prior year. Income from donations and grants increased from £100,636 to £112,178 in the year, however fundraising income was £900 (2023 £9,766). Our donations to assist children totalled £112,997 (2023: £117,796) in the year. This was a decrease of £4,799 (2023 increase £5,986) in the year.

At the end of the year we had a small deficit of £8,417 (2023: £8,978 deficit), which, with reserves brought forward of £16,882, there are reserves carried forward of £8,465.

Support costs for the year totalled £4,136 (2023: £1,584). Whilst this is an increase from last year, we continue to be able to minimise our support costs as much of the finance and administrative effort is provided by volunteers.

The Foundation aims to keep reserve at a minimum by distributing funds in accordance with the objects, directly to children and their families. In the year to 31 December 2024, 93% of expenditure is related to assistance and direct costs of raising voluntary income. Reserves were £8,465 at 31 December 2024.

c. Principal risks and uncertainties

There are no significant risks involved in The Link Foundation as we do not offer practical help to individuals or other charities. We do provide financial help to disadvantaged children and their families, who have been directed to us from our partners in the community; however, we do not meet these individuals and therefore do not have to be DBS checked.

d. Principal funding

Funding to support activities is from personal and corporate donations and a few fundraising events.

Structure, governance and management

a. Constitution

The charity is a company limited by guarantee and an exempt charity. The charitable company's memorandum and articles of association are the primary governing documents of the charity. The trustees of the charity are also the directors of the charitable company for the purposes of company law.

b. Methods of appointment or election of Trustees

Appointment to the board of trustees is by invitation after the needs of the charity and the range of suitable candidates are considered by the current trustees.

c. Organisational structure and decision-making policies

The overall strategic direction of the charity is determined by the trustees who meet formally monthly. The Trustees meet monthly to adjudicate on the applications for funding. Decisions are made based on the criteria of the charity and how important the needs of the applicant are.

d. Policies adopted for the induction and training of Trustees

The induction of new trustees is tailored to the needs of the individual concerned and would, however, always include the provision of key documents and information relating to our activities and obligations under the Charities Commission.

e. Related party relationships

The Link Foundation works in partnership with other charities, domestic violence refuges, schools, the Family Nurse Partnership, Sure Start children centers and Health Visitors in the community. These strategic partners screen all individuals applying to the charity and confirm that they agree with what is being asked for. In many instances, they will also help the applicant complete the application form to ensure it is comprehensive and precise. This procedure ensures that applicants are bona fide, and the trustees have confidence that their need is valid. The Link Foundation application form allows the trustees to understand the demographic, benefits, and income information so that more accurate metrics can be recorded. Businesses and individuals who donate to the Link Foundation can now look at who we help in the community and overseas.

Plans for future periods

The Link Foundation aims to donate in the region of £8,000 per month to disadvantaged families in the Community.

Members' liability

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

Statement of Trustees' responsibilities



They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Independent examiner's report to the Trustees of The Link Foundation ('the company')

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 DECEMBER 2024

1. General information

The company is a company limited by guarantee. The members of the company are the Trustees named on page 1. In the event of the company being wound up, the liability in respect of the guarantee is limited to £10 per member of the company.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The Link Foundation meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Going concern

The financial statements have been prepared on a going concern basis as the Trustees believe that no material uncertainties exist. The Trustees have considered the level of funds held and the expected level of income and expenditure for the 12 months from authorising these financial statements. The budgeted income and expenditure is sufficient with the level of reserves for the charity to be able to continue as a going concern.

2.3 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Grants are included in the Statement of financial activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

Donated services or facilities are recognised when the company has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use of the company item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102), the general volunteer time of the Friends is not recognised and refer to the Trustees' Report for more information about their contribution.

2.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources.

Expenditure on raising funds includes all expenditure incurred by the company to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the company's objectives, as well as any associated support costs.

Grants payable are charged in the year when the offer is made except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled. Grants offered subject to conditions which have not been met at the year end are noted as a commitment, but not accrued as expenditure.

All expenditure is inclusive of irrecoverable VAT.

2.5 Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the company; this is normally upon notification of the interest paid or payable by the bank.

2.6 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

2.7 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

2.8 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

Liabilities are recognised at the amount that the company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

2.9 Financial instruments

The company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

2.10 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

TRUSTEES' REPORT
FOR THE YEAR ENDED 31 DECEMBER 2023

The Trustees present their report and the unaudited financial statements of the charity for the year ended 31 December 2023. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

Since the company qualifies as small under section 383, the strategic report required of medium and large companies under The Companies Act 2006 (Strategic Report and Director's Report) Regulations 2013 is not required.

The Link Foundation is a voluntarily staffed children's charity based in Maidenhead that is committed to improving the lives of children and their families in the local community and surrounding areas.

Objectives and activities

a. Policies and objectives

In setting objectives and planning for activities, the Trustees have given due consideration to general guidance published by the Charity Commission relating to public benefit, including the guidance 'Public benefit: running a charity (PB2)'.

The Link Foundation aims to help as many disadvantaged children as possible in Maidenhead, Slough, Windsor, Ascot, Bracknell, Marlow and Wycombe. Working with their strategic partners, the charity identifies families who are struggling to provide essentials for their children. The charity is always reaching out to new groups so they can endeavor to help as many children as possible and the trustees regularly meet with health visitors and schools to educate them on how the Link Foundation can help their families.

b. Strategies for achieving objectives

We do not always see them around us but there are many families quietly struggling to give their children the kind of basics many of us take for granted. 2023 continued to be a hard year for many families in the community as the Covid-19 pandemic forced many parents on low income and zero hour contracts to lose their jobs. Many families who had never approached the Link Foundation before, found themselves applying for vouchers for food, clothes, and hygiene essentials as they struggled to make ends meet..

At the Link Foundation, we aim to help these children by providing grants to cover their specific needs. In addition to this, in 2023 the Link Foundation was still able to assist the international charity WORK, a Kenyan charity set up to help widows and girls in a rural community, with a grant of £5,000.

The Link Foundation aims to help local children in difficult circumstances regardless of background, race, or religion, when we know our assistance will make a real difference to them. These could be children living with a disability, children who have suffered parental illness or desertion, children who are living in a domestic violence refuge or children whose parents simply can't afford the basics or "little extras" a child needs. Each year we are delighted to be able to help hundreds of our local children and their families.

Uniquely, we work very closely with local partners such as healthcare and educational professionals who are right at the heart of the community and can identify, and refer to us, the children who will most benefit from our help.

All our partners, including Health Visitors, Family Nurses, School and Nursery Staff, Community Groups, local Charity Staff, Social Services and Domestic Violence Workers are vital to us. We only accept applications through our partners, who use our application form to indicate their support for the application. They also know the many deserving families whose children may need our help but would not necessarily ask for it.

Given that The Link Foundation is staffed entirely by volunteers, and we do not have the resources to visit and verify all applications made, this support is invaluable. It also means we can operate on a tiny infrastructure and, as a result, an incredible 95% of all funds raised goes directly to the children and their families.

We believe at The Link Foundation that even a small gesture can make a big difference in a child's life.

c. Fundraising practices

Since its inception in 2006, the Link Foundation has held annual events to raise funds for the charity. This included Fireworks and Fun, Let's Rock the Moor and the Link Ball. Since 2022, and mainly as the result of the pandemic, the Link Foundation has moved away from major fundraising events and has actively pursued grant applications to other foundations and trusts coupled with a drive to engage businesses and their corporate responsibility programs. It is hoped that in 2024 the charity will recruit new businesses, including Mattel, to help fundraise for the charity.

In 2023, the Link Foundation received donations from other trusts including the Louis Baylis trust, St James Place, the Berkshire Community Foundation, the Masonic Community Foundation and the Louis Baylis Trust.

The Link Foundation does not approach the public for donations unless it is as part of a wider fundraising events such as the Maidenhead Boundary Walk so protection of the public does not apply to the charity.

The Link Foundation plans any fundraising events a year in advance and our standards of fundraising are rigorously adhered to by the trustees..

d. Main activities undertaken to further the company's purposes for the public benefit

The Link Foundation regularly provides grants to help children enjoy a significant improvement to their lives, whether it's to cover emergency needs or to buy something more long term. This can mean giving vouchers to buy essentials such as shoes or school uniforms. We also provide funding for essential household items or specialized equipment to help less able-bodied children be more comfortable at home, as well as funding opportunities for children to be included in a school trip or a short break away. Sometimes, we can help local families by passing on good quality, nearly new children's clothing, toys, baby equipment etc. that have been donated to us.

In 2023 the Link Foundation was faced with the continuing impact of the Covid-19 pandemic and the fact that local services in the community have been decimated. Many families, who were already struggling, were thrown into greater poverty.

In 2023, the Link Foundation benefited hugely from the pharmaceutical company Biogen who donated more than £30,000, much of which was raised by selling their office furniture during the company's recent office move. Other notable donations included £11,000 from the Berkshire Community Foundation, £6,000 from the Masonic Community Fund, £4,500 from the Louis Baylis Trust and £8,760 from the Charities Trust. The Link Foundation also received an amazingly generous donation of £12,000 from MCS Rentals and the Vanderknapp family trust, which means the company and family have donated over £32,000 from 2020.

In 2023, the Link Foundation continued its valuable partnership with the Family Nurse Partnership, situated at

Wycombe General Hospital. This initiative is dedicated to assisting very young mothers who often face financial challenges while caring for their children. The Link Foundation played a crucial role by providing essential items for babies, including cots, prams, and beds. These contributions helped these mothers establish nurturing homes for their families. The Family Nurse Partnership has expressed overwhelmingly positive feedback, as they believe that the Link Foundation not only aids these young mothers in building self-esteem but also provides vital support for their newborns.

During the Christmas season of 2023, the Link Foundation extended its generosity to 25 local children's centers and schools that support disadvantaged families. The fund for Christmas presents primarily came from Biogen Idec, a local pharmaceutical company, but the charity was also ably assisted by Lapland UK, which donated hundreds of Christmas presents to families supported by the Link Foundation. Additionally, Berkshire Community Foundation donated £5,000 to help buy dinners for families in need at Christmas. With these funds, the Link Foundation was able to distribute Christmas dinners to over 500 families in the community. These families had been referred to the Link Foundation by local health visitors and received a £25 Sainsbury voucher, ensuring they could enjoy a festive holiday season.

The Link Foundation collaborates closely with several local charities to identify and assist the most vulnerable families in the community. These partners include organizations such as Family Friends, DASH, Hestia, and Abri, and the Link Foundation regularly receives applications from these groups. In addition to these local charities, the Link Foundation also works in coordination with the RBWM (Royal Borough of Windsor and Maidenhead) social services team. In 2023, the charity continued its valuable partnership with the Family Resilience Service and Health Visitors in Wycombe, given the substantial need for support in East Berkshire and South Buckinghamshire.

Notably, the Link Foundation received numerous applications for aid from Slough Borough Council and Slough Children's Services in 2023, showcasing the strong relationships it maintains with these organizations. The charity also extended invitations for applications to the Achieving for Children health visiting team in Maidenhead, the Slough health visiting team, Solutions 4 Health, as well as children's centres and health visitors in Bracknell and Bracknell Forest Council.

The charity's trustees strive to visit its strategic partners annually to assess how effectively the charity is assisting families and to enhance the services provided to the community. Unfortunately, due to the pandemic, in-person visits were not feasible as personnel were working remotely. However, the trustees are committed to arranging meetings with strategic partners in 2024 or whenever individuals return to their workplaces.

Achievements and performance

a. Main achievements of the company

In 2023 the Link Foundation worked with the health visiting teams in Maidenhead, Slough, Bracknell, Windsor, Reading, Wycombe, and Marlow as well as local schools to identify families that were finding life incredibly difficult. The Link Foundation helps families by donating Argos and Sainsbury vouchers, which can be given quickly to families in need, and, in some cases, health visitors asked for urgent help for families and the charity gave emergency help in the form of vouchers that were picked up directly from the office.

In addition to our local work, the Link Foundation continued to work internationally, although this has declined in recent years due to the pressures on the charity's resources from local families living in poverty. In 2023 the Link Foundation donated £5,000 to assist an overseas children's charity WORK in Kenya. The Widows and Orphans in Rural Kenya (WORK) is an amazing charity set up by Mary-Jane Butler with the aim to help the numerous elderly women who care for their grandchildren as the parents have died from Aids. WORK also helps young girls to get to school in a very dangerous environment where they can be raped regularly.

It is vital that we have robust partnerships with the overseas charities with whom we work to ensure that any donations are going directly to the children we wish to help. In 2024 the Link Foundation will review the aid it gives to developing countries as many of the charity sponsors insist that their donations go to help local families.

The Link Foundation relies on the continuing flow of donations to fund its grant giving activity and this was never truer as in 2023.

The Link Foundation received several generous donations both personally and from businesses, including the following personal donations - £10,000 from Peter Griffin, £1,000 from the Allanson family, £1,000 from Patricia Losel, £1,000 from the Stewart family and some smaller donations from other local families.

The Charity also had some sizeable donations from local businesses and foundations. The Berkshire Community Foundation donated £11,000, Lets Rock the Moor raised £8,000, Louis Baylis Trust £4,500, Maidenhead United Football Club donated £2,000 and 52 Lives donated £1,600 to help with the Link Foundation Christmas appeal.

Nicola Ross was recruited as a trustee in 2020 and her remit has been to create a presence for the Link Foundation on various social media platforms. Nicola is a great asset to the charity and her work continued and expanded throughout 2023 and the difference she has made with fundraising is indicated by the increase of money donated via JustGiving, which is a direct response from social media campaigns on LinkedIn, Facebook, Instagram and Twitter and this will continue throughout 2024. Nicola has also taken on the role of gatekeeper for the Link Foundation website, which is another key element in our charity fundraising campaigns.

At the end of 2021 the trustees agreed that a new website was needed as the old website was not supported technically anymore and was also very outdated. It was recognized that a website is very important as it can be the first interface potential sponsors or volunteers have with the charity. The website was completed in 2023, and all the trustees were thrilled with the finished product as it gives a great initial impression of the charity to families and sponsors alike.

b. Key performance indicators

The Foundation aims to keep reserves at a minimum by distributing funds in accordance with the objects, directly to children and their families. In the year to December 2023, 98% of expenditure is related to assistance and direct costs of raising voluntary income.

Financial review

a. Going concern

After making appropriate enquiries, the board of trustees has a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. For this reason, it continues to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Statement of Accounting Policies.

b. Reserves policy

The work of the trustees generated total incoming resources of £110,402 (2022: £116,235) which is a decrease of 5% from the prior year. Income from donations and grants increased from £76,612 to £100,636 in the year, however fundraising income was £9,766 (2022: £39,623). Our donations to assist children totalled £117,796 (2022: £111,810) in the year. This was an increase of £5,986 in the year.

At the end of the year we had a small deficit of £8,978 (2022: £9,254 deficit), which, with reserves brought forward of £25,860, there are reserves carried forward of £16,882.

Support costs for the year totalled £1,584 (2022: £3,191). We continue to be able to minimise our support costs as much of the finance and administrative effort is provided by volunteers.

The Foundation aims to keep reserve at a minimum by distributing funds in accordance with the objects, directly to children and their families. In the year to 31 December 2023, 98% of expenditure is related to assistance and direct costs of raising voluntary income. Reserves were £16,882 at 31 December 2023.

c. Principal risks and uncertainties

There are no significant risks involved in The Link Foundation as we do not offer practical help to individuals or other charities. We do provide financial help to disadvantaged children and their families, who have been directed to us from our partners in the community; however, we do not meet these individuals and therefore do not have to be DBS checked.

d. Principal funding

Funding to support activities is from personal and corporate donations and a few fundraising events.

Structure, governance and management

a. Constitution

The charity is a company limited by guarantee and an exempt charity. The charitable company's memorandum and articles of association are the primary governing documents of the charity. The trustees of the charity are also the directors of the charitable company for the purposes of company law.

b. Methods of appointment or election of Trustees

Appointment to the board of trustees is by invitation after the needs of the charity and the range of suitable candidates are considered by the current trustees.

c. Organisational structure and decision-making policies

The overall strategic direction of the charity is determined by the trustees who meet formally monthly. The Trustees meet monthly to adjudicate on the applications for funding. Decisions are made based on the criteria of the charity and how important the needs of the applicant are.

d. Policies adopted for the induction and training of Trustees

The induction of new trustees is tailored to the needs of the individual concerned and would, however, always include the provision of key documents and information relating to our activities and obligations under the Charities Commission.

e. Related party relationships

The Link Foundation works in partnership with other charities, domestic violence refuges, schools, the Family Nurse Partnership, Sure Start children centers and Health Visitors in the community. These strategic partners screen all individuals applying to the charity and confirm that they agree with what is being asked for. In many instances, they will also help the applicant complete the application form to ensure it is comprehensive and precise. This procedure ensures that applicants are bona fide, and the trustees have confidence that their need is valid. The Link Foundation application form allows the trustees to understand the demographic, benefits, and income information so that more accurate metrics can be recorded. Businesses and individuals who donate to the Link Foundation can now look at who we help in the community and overseas.

Plans for future periods

The Link Foundation aims to donate in the region of £8,000 per month to disadvantaged families in the Community.

Members' liability

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.



Independent examiner's statement


I have completed my examination. I confirm that no matters have come to my attention in connection with the examination giving me cause to believe:



1. General information

The company is a company limited by guarantee. The members of the company are the Trustees named on page 1. In the event of the company being wound up, the liability in respect of the guarantee is limited to £10 per member of the company.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The Link Foundation meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Going concern

The financial statements have been prepared on a going concern basis as the Trustees believe that no material uncertainties exist. The Trustees have considered the level of funds held and the expected level of income and expenditure for the 12 months from authorising these financial statements. The budgeted income and expenditure is sufficient with the level of reserves for the charity to be able to continue as a going concern.

2.3 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Grants are included in the Statement of financial activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

Donated services or facilities are recognised when the company has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use of the company item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102), the general volunteer time of the Friends is not recognised and refer to the Trustees' Report for more information about their contribution.

2.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources.

Expenditure on raising funds includes all expenditure incurred by the company to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the company's objectives, as well as any associated support costs.

Grants payable are charged in the year when the offer is made except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled. Grants offered subject to conditions which have not been met at the year end are noted as a commitment, but not accrued as expenditure.

All expenditure is inclusive of irrecoverable VAT.

2.5 Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the company; this is normally upon notification of the interest paid or payable by the bank.

2.6 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

2.7 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

2.8 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

Liabilities are recognised at the amount that the company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

TRUSTEES' REPORT
FOR THE YEAR ENDED 31 DECEMBER 2022

The Trustees present their report and the unaudited financial statements of the charity for the year ended 31 December 2022. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

Since the company qualifies as small under section 383, the strategic report required of medium and large companies under The Companies Act 2006 (Strategic Report and Director's Report) Regulations 2013 is not required.

The Link Foundation is a voluntarily staffed children's charity based in Maidenhead that is committed to improving the lives of children and their families in the local community and surrounding areas.

Objectives and activities

a. Policies and objectives

In setting objectives and planning for activities, the Trustees have given due consideration to general guidance published by the Charity Commission relating to public benefit, including the guidance 'Public benefit: running a charity (PB2)'.

The Link Foundation aims to help as many disadvantaged children as possible in Maidenhead, Slough, Windsor, Ascot, Bracknell, Marlow and Wycombe. Working with their strategic partners, the charity identifies families who are struggling to provide essentials for their children. The charity is always reaching out to new groups so they can endeavor to help as many children as possible and the trustees regularly meet with health visitors and schools to educate them on how the Link Foundation can help their families.

b. Strategies for achieving objectives

We do not always see them around us but there are many families quietly struggling to give their children the kind of basics many of us take for granted. 2022 was an especially hard year for many families in the community as the Covid-19 pandemic forced many parents on low income and zero-hour contracts to lose their jobs. Many families who had never approached the Link Foundation before, found themselves applying for vouchers for food, clothes, and hygiene essentials as they struggled to make ends meet.

At the Link Foundation, we aim to help these children by providing grants to cover their specific needs. In addition to this, in 2022 the Link Foundation was still able to assist the international charity WORK, a Kenyan charity set up to help widows and girls in a rural community, with a grant of £3,000. Other international charities helped included Transplant Links in the Community, who received £3,000 and the Congo Children's Trust who received £5,000.

The Link Foundation aims to help local children in difficult circumstances regardless of background, race, or religion, when we know our assistance will make a real difference to them. These could be children living with a disability, children who have suffered parental illness or desertion, children who are living in a domestic violence refuge or children whose parents simply can't afford the basics or "little extras" a child needs. Each year we are delighted to be able to help hundreds of our local children and their families.

Uniquely, we work very closely with local partners such as healthcare and educational professionals who are right at the heart of the community and can identify, and refer to us, the children who will most benefit from our help.

All our partners, including Health Visitors, Family Nurses, School and Nursery Staff, Community Groups, local Charity Staff, Social Services and Domestic Violence Workers are vital to us. We only accept applications through our partners, who use our application form to indicate their support for the application. They also know the many deserving families whose children may need our help but would not necessarily ask for it.

Given that The Link Foundation is staffed entirely by volunteers, and we do not have the resources to visit and verify all applications made, this support is invaluable. It also means we can operate on a tiny infrastructure and, as a result, an incredible 95% of all funds raised goes directly to the children and their families.

We believe at The Link Foundation that even a small gesture can make a big difference in a child's life.

c. Fundraising practices

Since its inception in 2006, the Link Foundation has held annual events to raise funds for the charity. This includes Fireworks and Fun, Let's Rock the Moor and the Link Ball. These are the main fundraising events, and these are supplemented with fundraising events that are organised on our behalf by supporters of the charity. In addition to this, the Link Foundation receives donations from other trusts including St James Wealth, the Berkshire Community Foundation, Biogen Idec and the Louis Baylis Trust.

The Link Foundation does not approach the public for donations unless it is as part of a wider fundraising events such as the Link Ball so protection of the public does not apply to the charity.

The Link Foundation plans any fundraising a year in advance and our standards of fundraising are rigorously adhered to by the trustees.

d. Main activities undertaken to further the company's purposes for the public benefit

In 2022 the Link Foundation was faced with the continuing impact of the Covid-19 pandemic and many families, who were already struggling, were thrown into greater poverty. The Link Foundation trustees were incredibly pleased that in 2022 they were able to stage the Link Ball after a 4-year absence due to the pandemic and this provided much needed funds for the charity.

In addition to the ball, the trustees looked at grant givers such as Berkshire Community Foundation, Louis Baylis Trust and The Prince Philip Trust Fund for additional help throughout the year, and the charity also received generous donations, both personal and corporate, meaning that the Link Foundation could continue to help hundreds of families in the community throughout 2022.

In 2022, the Link Foundation continued its valuable partnership with the Family Nurse Partnership, situated at Wycombe General Hospital. This initiative is dedicated to assisting very young mothers who often face financial challenges while caring for their children. The Link Foundation played a crucial role by providing essential items for babies, including cots, prams, and beds. These contributions helped these mothers establish nurturing homes for their families. The Family Nurse Partnership has expressed overwhelmingly positive feedback, as they believe that the Link Foundation not only aids these young mothers in building self-esteem but also provides vital support for their newborns.

During the Christmas season of 2022, the Link Foundation extended its generosity to 25 local children's centers and schools that support disadvantaged families. The funds for Christmas presents primarily came from Biogen Idec, a local pharmaceutical company, whose employees generously donated money through Benevity. Remarkably, the company matched these donations, resulting in a total contribution exceeding £10,000. With these funds, the Link Foundation was able to distribute Christmas dinners to over 500 families in the community. These families had been referred to the Link Foundation by local health visitors and received a £25 Sainsbury

voucher, ensuring they could enjoy a festive holiday season.

The Link Foundation collaborates closely with several local charities to identify and assist the most vulnerable families in the community. These partners include organizations such as Family Friends, P3, DASH, Hestia, and Abri, and the Link Foundation regularly receives applications from these groups. In addition to these local charities, the Link Foundation also works in coordination with the RBWM (Royal Borough of Windsor and Maidenhead) social services team. In 2022, the charity continued its valuable partnership with the Family Resilience Service and Health Visitors in Wycombe, given the substantial need for support in East Berkshire and South Buckinghamshire.

Notably, the Link Foundation received numerous applications for aid from Slough Borough Council and Slough Children's Services in 2022, showcasing the strong relationships it maintains with these organizations. The charity also extended invitations for applications to the Achieving for Children health visiting team in Maidenhead, the Slough health visiting team, Solutions 4 Health, as well as children's centres and health visitors in Bracknell and Bracknell Forest Council.

The charity's trustees strive to visit its strategic partners annually to assess how effectively the charity is assisting families and to enhance the services provided to the community. Unfortunately, due to the pandemic, in-person visits were not feasible as personnel were working remotely. However, the trustees are committed to arranging meetings with strategic partners in 2023 or whenever individuals return to their workplaces.

One of The Link Foundation's key objectives is to complement donations with fundraising events. In 2022, the trustees successfully hosted the Link Foundation Ball, marking its return after a four-year hiatus caused by the pandemic. This event raised an impressive £30,000, providing a significant boost to the charity's mission.

Achievements and performance

a. Main achievements of the company

In 2022 the Link Foundation worked with the health visiting teams in Maidenhead, Slough, Bracknell, Windsor, Reading, Wycombe, and Marlow as well as local schools to identify families that were finding life post pandemic incredibly difficult. The Link Foundation helps families by donating Argos and Sainsbury vouchers, which can be given quickly to families in need, and, in some cases, health visitors asked for urgent help for families and the charity gave emergency help in the form of vouchers that were picked up directly from the office.

In addition to our local work, the Link Foundation continued to work internationally. In 2022 the Link Foundation donated £3,000 to assist an overseas children's charity WORK in Kenya. The Widows and Orphans in Rural Kenya (WORK) is an amazing charity set up by Mary-Jane Butler with the aim to help the numerous elderly women who care for their grandchildren as the parents have died from Aids. WORK also helps young girls to get to school in a very dangerous environment where they can be raped regularly.

Additionally, the charity donated £3,000 to Transplant Links in the Community, a charity that we have partnered with for 10 years. A donation of £5,000 was also given to the Congo Children's Trust, which helps fund schools in the Congo.

It is vital that we have robust partnerships with the overseas charities with whom we work to ensure that any donations are going directly to the children we wish to help. In 2023 the Link Foundation will strive to donate more money to developing countries as we have excellent contacts in the UK who advise on which charities, we are in the position to support. However, this will only be possible if there is enough money raised to help local families, some of whom are in terrible situations due to the impact of the pandemic.

The Link Foundation relies on the continuing flow of donations to fund its grant giving activity and this was never truer as in 2022.

The Link Foundation received several generous donations both personally and from businesses, including the following personal donations - £10,000 from Peter Griffin, £1,000 from the Allanson family, £1,000 from the Stewart family and some smaller donations from other local families.

The Charity also had some sizeable grants and donations from local businesses and foundations. The Berkshire Community Foundation granted £6,000, Lets Rock the Moor raised £8,000, Louis Baylis Trust granted £4,000 and Maidenhead United Football Club donated £2,000. Indira Weaver also raised £3,000 in sponsorship for the Link Foundation by climbing Mount Aconcagua, which was an amazing achievement.

Nicola Ross was recruited as a trustee in 2020 and her remit has been to create a presence for the Link Foundation on various social media platforms. Nicola is a great asset to the charity and her work continued throughout 2022 and the difference she has made with fundraising is indicated by the increase of money donated via JustGiving, which is a direct response from social media campaigns on LinkedIn, Facebook, Instagram and Twitter and this will continue throughout 2023.

At the end of 2021 the trustees agreed that a new website was needed as the old website is not supported technically anymore and is also very outdated and it is recognized that a website is very important as it can be the first interface potential sponsors or volunteers have with the charity. A key objective of 2022 was to appoint a company to create a new and easier website with less detail but key priorities visible and this was achieved when we appointed a local company called Orange Grove to design and create a website and this will hopefully be completed in 2023.

Achievements and performance (continued)

One of the greatest successes the Link Foundation has achieved in the last 15 years occurred in 2021 when the charity was awarded a Queens Award for Voluntary Services in recognition of the work the charity has done in the community, with special recognition for the outstanding effort during the Covid pandemic. The trustees and volunteers at the Link Foundation were incredibly touched to win this award as it was such a community effort.

b. Key performance indicators

The Foundation aims to keep reserves at a minimum by distributing funds in accordance with the objects, directly to children and their families. In the year to December 2022, 97% of expenditure is related to assistance and direct costs of raising voluntary income.

Financial review

a. Going concern

After making appropriate enquiries, the board of trustees has a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. For this reason, it continues to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Statement of Accounting Policies.

b. Reserves policy

The work of the trustees generated total incoming resources of £116,235 (2021: £94,931) which is an increase of 23% from the prior year. Income from donations decreased from £94,931 to £76,612 in the year, however fundraising income was £39,623 (2021: £nil). Our donations to assist children totalled £111,810 (2021: £82,623) in the year. This was an increase of £29,187 in the year.

At the end of the year we had a small deficit of £9,254 (2021: £7,993 surplus), which, with reserves brought forward of £35,114, there are reserves carried forward of £25,860.

Support costs for the year totalled £3,191 (2021: £3,905). We continue to be able to minimise our support costs as much of the finance and administrative effort is provided by volunteers.

The Foundation aims to keep reserve at a minimum by distributing funds in accordance with the objects, directly to children and their families. In the year to 31 December 2022, 97% of expenditure is related to assistance and direct costs of raising voluntary income. Reserves were £25,860 at 31 December 2022.

c. Principal risks and uncertainties

There are no significant risks involved in The Link Foundation as we do not offer practical help to individuals or other charities. We do provide financial help to disadvantaged children and their families, who have been directed to us from our partners in the community; however, we do not meet these individuals and therefore do not have to be DBS checked.

d. Principal funding

Funding to support activities is from personal and corporate donations and a few fundraising events.

Structure, governance and management

a. Constitution

The charity is a company limited by guarantee and an exempt charity. The charitable company's memorandum and articles of association are the primary governing documents of the charity. The trustees of the charity are also the directors of the charitable company for the purposes of company law.

b. Methods of appointment or election of Trustees

Appointment to the board of trustees is by invitation after the needs of the charity and the range of suitable candidates are considered by the current trustees.

c. Organisational structure and decision-making policies

The overall strategic direction of the charity is determined by the trustees who meet formally monthly. The Trustees meet monthly to adjudicate on the applications for funding. Decisions are made based on the criteria of the charity and how important the needs of the applicant are.

d. Policies adopted for the induction and training of Trustees

The induction of new trustees is tailored to the needs of the individual concerned and would, however, always include the provision of key documents and information relating to our activities and obligations under the Charities Commission.

e. Related party relationships

The Link Foundation works in partnership with other charities, domestic violence refuges, schools, the Family Nurse Partnership, Sure Start children centers and Health Visitors in the community. These strategic partners screen all individuals applying to the charity and confirm that they agree with what is being asked for. In many instances, they will also help the applicant complete the application form to ensure it is comprehensive and precise. This procedure ensures that applicants are bona fide, and the trustees have confidence that their need is valid. The Link Foundation application form allows the trustees to understand the demographic, benefits, and income information so that more accurate metrics can be recorded. Businesses and individuals who donate to the Link Foundation can now look at who we help in the community and overseas.

Plans for future periods

The Link Foundation aims to donate in the region of £7,500 per month to disadvantaged families in the community and also donate up to 10% of the charity funds in 2022 to our international partners.

Members' liability

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

Statement of Trustees' responsibilities

The Trustees (who are also the directors of the company for the purposes of company law) are responsible for preparing the Trustees' report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the Trustees to prepare financial statements for each financial . Under company law, the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the company and of its incoming resources and application of resources, including its income and expenditure, for that period. In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles of the Charities SORP (FRS 102);
- make judgments and accounting estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards (FRS 102) have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The Trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. 1. General information

The company is a company limited by guarantee. The members of the company are the Trustees named on page 1. In the event of the company being wound up, the liability in respect of the guarantee is limited to £10 per member of the company.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The Link Foundation meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Going concern

The financial statements have been prepared on a going concern basis as the Trustees believe that no material uncertainties exist. The Trustees have considered the level of funds held and the expected level of income and expenditure for the 12 months from authorising these financial statements. The budgeted income and expenditure is sufficient with the level of reserves for the charity to be able to continue as a going concern.

2.3 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Grants are included in the Statement of financial activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

Donated services or facilities are recognised when the company has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use of the company item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102), the general volunteer time of the Friends is not recognised and refer to the Trustees' Report for more information about their contribution.

2. Accounting policies (continued)

2.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources.

Expenditure on raising funds includes all expenditure incurred by the company to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the company's objectives, as well as any associated support costs.

Grants payable are charged in the year when the offer is made except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled. Grants offered subject to conditions which have not been met at the year end are noted as a commitment, but not accrued as expenditure.

All expenditure is inclusive of irrecoverable VAT.

2.5 Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the company; this is normally upon notification of the interest paid or payable by the bank.

2.6 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

2.7 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

2.8 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

Liabilities are recognised at the amount that the company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

2.9 Financial instruments

Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

2.10 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

The Trustees present their annual report together with the financial statements of the company for the year 1 January 2020 to 31 December 2020. The Annual report serves the purposes of both a Trustees' report and a directors' report under company law. The Trustees confirm that the Annual report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the company qualifies as small under section 382 of the Companies Act 2006, the Strategic report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

Objectives and activities

a. Policies and objectives

The Link Foundation is a voluntarily staffed children's charity based in Maidenhead that is committed to improving the lives of children and their families in the local community and surrounding areas

In setting objectives and planning for activities, the Trustees have given due consideration to general guidance published by the Charity Commission relating to public benefit, including the guidance 'Public benefit: running a charity (PB2)'.

The Link Foundation aims to help as many disadvantaged children as possible in Maidenhead, Slough, Windsor, Ascot, Bracknell, Marlow and Wycombe. Working with their strategic partners, the charity identifies families who are struggling to provide essentials for their children. The charity is always reaching out to new groups so they can endeavor to help as many children as possible and the trustees regularly meet with health visitors and schools to educate them on how the Link Foundation can help their families.

b. Strategies for achieving objectives

We do not always see them around us but there are many families quietly struggling to give their children the kind of basics many of us take for granted. 2020 was an especially hard year for many families in the community as the Covid-19 pandemic forced many parents on low income and zero-hour contracts to lose their jobs. Many families who had never approached the Link Foundation before, found themselves applying for vouchers for food, clothes, and hygiene essentials as they struggled to make ends meet.

At the Link Foundation, we aim to help these children by providing grants to cover their specific need. In addition to this, in 2020 the Link Foundation was still able to assist two international charities with grants totally £10,000. WORK, a Kenyan charity set up to help widows and girls in a rural community was given £6,000 and TLC, a charity that supports surgeons in developing countries to learn how to do kidney transplants, received £4,000.

The Link Foundation aims to help local children in difficult circumstances regardless of background, race, or religion, when we know our assistance will make a real difference to them. These could be children living with a disability, children who have suffered parental illness or desertion, children who are living in a domestic violence refuge or children whose parents simply can't afford the basics or "little extras" a child need. Each year we are delighted to be able to help hundreds of our local children and their families.

Uniquely, we work very closely with local partners such as healthcare and educational professionals who are right at the heart of the community and can identify, and refer to us, the children who will most benefit from our help.

All our partners, including Health Visitors, Family Nurses, School and Nursery Staff, Community Groups, Local Charity Staff, Social Services and Domestic Violence Workers are vital to us. We only accept applications through our partners, who use our application form to indicate their support of the application. They also know the many deserving families whose children may need our help but would not necessarily ask for it. Given that The Link Foundation is staffed entirely by volunteers, and we do not have the resources to visit and verify all applications made, this support is invaluable. It also means we can operate on a tiny infrastructure and, as a result, an incredible 95% of all funds raised goes directly to the children and their families.

We believe at The Link Foundation that even a small gesture can make a big difference in a child's life.

c. Fundraising practices

Since its inception in 2006, the Link Foundation has held annual events to raise funds for the charity. This includes, Fireworks and Fun, Let's Rock the Moor and the Link Ball. These are the main fundraising events and these are supplemented with fundraising events that are organised on our behalf by supporters of the charity. In addition to this, the Link Foundation receives donations from other trusts including the Louis Baylis trust, St James Wealth, the Berkshire Community Foundation and the Shanly Foundation.

The Link Foundation does not approach the general public for donations unless it is as part of a wider fundraising event such as the Link Ball so protection of the public does not apply to the charity.

The Link Foundation plans any fundraising a year in advance and our standards of fundraising are rigorously adhered to by the trustees.

d. Main activities undertaken to further the company's purposes for the public benefit

The Link Foundation regularly provide grants to help children enjoy a significant improvement to their lives, whether it's to cover emergency needs or to buy something more long term. This can mean giving vouchers to buy essentials such as shoes or school uniforms. We also provide funding for essential household items or specialised equipment to help less able-bodied children be more comfortable at home, as well as funding opportunities for children to be included in a school trip or a short break away. Sometimes, we can help local families by passing on good quality, nearly new children's clothing, toys, baby equipment etc. that have been donated to us.

In 2020 the Link Foundation was faced with a unique situation when the Covid-19 pandemic struck and many families, who were already struggling, were thrown into greater poverty. The charity did have to review how it could raise funds as the planned fundraising events, including the Link Ball, had to be shelved. The trustees looked at grant givers such as Berkshire Community Foundation for additional help and the charity also received generous donations, both personal and corporate, meaning that the Link Foundation could continue to help hundreds of families in the community throughout 2020.

In 2020 the Link Foundation continued to partner with the Family Nurse Partnership based at Wycombe General Hospital, an initiative set up to help very young mothers who are often struggling to make ends meet and look after their children. The Link Foundation has been able to provide many baby essentials, such as cots, prams and beds to help these mothers create a home for their family. Feedback from the Family Nurse Partnership has been incredibly positive as they feel the Link Foundation helps these very young mothers build their self-esteem and support them with their new babies.

At Christmas 2020 the Link Foundation provided Christmas presents to 25 local children's centres and schools who support disadvantaged families. These presents had been donated by KKI in Marlow, Record Management in Windsor and Biogen, which is based in Maidenhead. The charity also provided Christmas dinners by donating a £25 Sainsbury voucher to over 500 families in the community who had been referred to the Link Foundation by local health visitors.

The Link Foundation work with other local charities to access those families who are most in need in the community and this includes, Family Friends, P3, DASH, Hestia and Radian and the charity receives regular applications from all these groups. In addition to local charities, the Link Foundation works with the RBWM social services team and in 2020, the charity continued to work with the Family Resilience Service and Health Visitors in Wycombe as there are so many families needing support in both boroughs.

The Link Foundation received many applications for aid from Slough Borough Council and Slough Children's Services in 2020 and the charity has excellent relationships with both organisations. The Link Foundation also invites applicants from the Achieving for Children health visiting team in Maidenhead, the Slough health visiting team, Solutions 4 Health, as well as the children's centres and health visitors in Bracknell and Bracknell Forest Council.

Trustees endeavor to visit the charity's strategic partners annually to review how the charity is working with the families and to improve the service given to the community, although this was not possible during the pandemic as all personnel were working from home. The trustees will try to meet with the strategic partners in 2021 or whenever individuals are back at their place of work.

A key objective of The Link Foundation is to supplement donations with further fundraising events, however all of the planned events had to be cancelled in 2020 due to the pandemic. The Link Foundation trustees looked for other avenues of funding so that the charity could continue to help vulnerable families and the charity was able to attract funds of over £131,000.

Achievements and performance

a. Main achievements of the company

In 2020 the Link Foundation worked with the health visiting teams in Maidenhead, Slough, Bracknell, Windsor, Reading, Wycombe and Marlow as well as local schools to identify families that were finding life in lockdown incredibly difficult. Additionally, the trustee meetings were conducted more regularly and also virtually to ensure help in the form of Argos and Sainsbury vouchers could be given quickly to families in need.

The Link Foundation also played a pivotal role in the Meals from Marlow project, which was formed to provide meals to families who otherwise may have found it impossible to feed their children during lockdown. The Link Foundation delivered 900 meals every week from April-December to families that had been identified by health visitors and parent support advisors as being vulnerable and in need of assistance. The Link Foundation also continued to regularly donate Argos vouchers and Sainsbury vouchers to help families purchase other essentials as well.

In addition to our local work, the Link Foundation continued to work internationally. In 2020 the Link Foundation donated £10,000 to assist overseas children's charities in Kenya and Jamaica. It is vital that we have robust partnerships with the overseas charities with whom we work to ensure that any donations are going directly to the children we wish to help. In 2021 the Link Foundation will strive to donate more of money to developing countries as we have excellent contacts in the UK who advise on which charities, we are in the position to support.

The Link Foundation helped two international charities recommended by colleagues and friends in Maidenhead. The Widows and Orphans in Rural Kenya (WORK) is an amazing charity set up by Mary-Jane Butler with the aim to help the numerous elderly women who care for their grandchildren as the parents have died from Aids. WORK also helps young girls to get to school in a very dangerous environment where they can be raped regularly.

The Link Foundation also assisted Transplant Links in the Community, a charity aimed at training surgeons to perform life saving kidney transplants in developing countries, with a grant of £4,000.

The Link Foundation relies on the continuing flow of donations to fund its grant giving activity and this was never truer as in 2020.

The Link Foundation received a number of generous donations both personally and from businesses. The charity received the following personal donations - £10,000 from Peter Griffin, £10,000 from the Hazeley family, £2,000 from the O'Sullivan family, £1,500 from Alma and Patrick Loughrey and some smaller donations from other local families.

The Charity also had some sizeable donations from local businesses and foundations. G&L Scientific donated £30,000, Berkshire Community Foundation donated £20,000, The National Lottery £10,000, The Vanderknapp Family Trust £10,000, Allergan International Foundation £9,000, The Shanly Foundation £7,000, The Englefield Trust £4,000, Louis Baylis £4,000 and Helena Shirley £1,300 as well as some smaller donations from local companies and Maidenhead United Football Club.

The Link Foundation were incredibly grateful for the grants and donations received as the Link Ball 2020 had to be cancelled as well as the Fireworks and Fun event, which usually bring in over £25,000 in revenue.

In 2020 the Link Foundation's recruited a new trustee, Nicola Ross, who has supported the charity for many years with fundraising events. Nicola is a great asset to the charity as she has taken on the role of social media manager for the charity as well as helping with grant applications. The trustees had understood for a long time that the charity social media was inadequate, and it needed to be revamped to improve communication with our various stakeholders.

In 2021, the Link Foundation is going to seek some sponsorship to create a new website as the old website is not supported any more and is also very outdated and it is recognized that a website is very important as it can be the first interface potential sponsors or volunteers have with the charity.

b. Key performance indicators

The Foundation aims to keep reserves at a minimum by distributing funds in accordance with the objects, directly to children and their families. In the year to December 2020, 99% of expenditure is related to assistance and direct costs of raising voluntary income.

Financial review

a. Going concern

After making appropriate enquiries, the Trustees have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. For this reason, they continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the accounting policies.

b. Reserves policy

The work of the trustees generated total incoming resources of £141,881 (2019: £83,297) which is an increase of 70% from the prior year. Income from donations has increased from £73,297 to £131,287 in the year. Our donations to assist children totalled £115,672 (2019: £86,758) in the year. This was an increase of £28,914 in the year.

At the end of the year we had a surplus of £20,191 (2019: £13,138 deficit), which, with reserves brought forward of £6,930 there are reserves carried forward of £27,121.

Support costs for the year totalled £3,928 (2019: £6,550). Whilst this is an increase from last year, we continue to be able to minimise our support costs as much of the finance and administrative effort is provided by volunteers.

The Foundation aims to keep reserves at a minimum by distributing funds in accordance with the objects, directly to children and their families. In the year to December 2020, 99% of expenditure is related to assistance and direct costs of raising voluntary income. Reserves were £27,121 at December 2020.

c. Principal risks and uncertainties

There are no significant risks involved in The Link Foundation as we do not offer practical help to individuals or other charities. We do provide financial help to disadvantaged children and their families, who have been directed to us from our partners in the community; however, we do not meet these individuals and therefore do not have to be CRB checked.

d. Principal funding

Funding to support activities is from personal and corporate donations and a few fundraising events.

Structure, governance and management

a. Constitution

The charity is a company limited by guarantee and an exempt charity. The charitable company's memorandum and articles of association are the primary governing documents of the charity. The trustees of the charity are also the directors of the charitable company for the purposes of company law.

b. Methods of appointment or election of Trustees

The management of the company is the responsibility of the Trustees who are elected and co-opted under the terms of the Memorandum of Association.

Appointment to the board of trustees is by invitation after the needs of the charity and the range of suitable candidates are considered by the current trustees.

c. Organisational structure and decision-making policies

The overall strategic direction of the charity is determined by the trustees who meet formally monthly. The Trustees meet monthly to adjudicate on the applications for funding. Decisions are made based on the criteria of the charity and how important the needs of the applicant are.

d. Policies adopted for the induction and training of Trustees

Induction of new trustees is tailored to the needs of the individual concerned and would, however, always include the provision of key documents and information relating to our activities and obligations under the Charities Commission.

e. Related party relationships

The Link Foundation works in partnership with other charities, domestic violence refuges, schools, the Family Nurse Partnership, Sure Start children centers and Health Visitors in the community. These strategic partners screen all individuals applying to the charity and confirm that they agree with what is being asked for. In many instances, they will also help the applicant complete the application form to ensure it is comprehensive and precise. This procedure ensures that applicants are bona fide, and the trustees have confidence that their need is valid. The Link Foundation application form allows the trustees to understand the demographic, benefits, and income information so that more accurate metrics can be recorded. Businesses and individuals who donate to the Link Foundation can now look at who we help in the community and overseas.

Plans for future periods

The Link Foundation aims to donate in the region of £7,500 per month to disadvantaged families in the community and also donate up to 20% of the charity funds in 2021 to our international partners.

They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 DECEMBER 2020

1. General information

The company is a company limited by guarantee. The members of the company are the Trustees named on page 1. In the event of the company being wound up, the liability in respect of the guarantee is limited to £10 per member of the company.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The Link Foundation meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Going concern

The financial statements have been prepared on a going concern basis as the Trustees believe that no material uncertainties exist. The Trustees have considered the level of funds held and the expected level of income and expenditure for the 12 months from authorising these financial statements. The budgeted income and expenditure is sufficient with the level of reserves for the charity to be able to continue as a going concern.

2.3 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Grants are included in the Statement of financial activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

Donated services or facilities are recognised when the company has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use of the company item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102), the general volunteer time of the Friends is not recognised and refer to the Trustees' Report for more information about their contribution.

2. Accounting policies (continued)

2.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources.

Expenditure on raising funds includes all expenditure incurred by the company to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the company's objectives, as well as any associated support costs.

Grants payable are charged in the year when the offer is made except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled. Grants offered subject to conditions which have not been met at the year end are noted as a commitment, but not accrued as expenditure.

All expenditure is inclusive of irrecoverable VAT.

2.5 Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the company; this is normally upon notification of the interest paid or payable by the bank.

2.6 Debtors

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

2.7 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

2.8 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

Liabilities are recognised at the amount that the company anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised in the Statement of financial activities as a finance cost.

2.9 Financial instruments

The company only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

2.10 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.
