TRUSTEES' REPORT
FOR THE YEAR ENDED 30 APRIL 2023

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 30 April 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The charity's main object is to relieve the suffering and distress that cats experience by rescuing abandoned, unwanted, mistreated, injured and homeless cats and kittens, providing veterinary care, food, accommodation as necessary, but with the ultimate aim of rehoming healthy animals where possible. In addition, the charity aims to trap, neuter and return feral cats and to educate the public in feline welfare.

The charity has considered the Charity Commission guidance on public benefit and the trustees are satisfied that the activities of the charity provide public benefit.

Significant activities

The charity has maintained its commitment to support owners who have lost their cats via the Lost and Found online register and offering advice and information to members of the public via online and telephone enquiries. We are very proud of our team of dedicated volunteers who work so hard to achieve this. The website continues to be an excellent resource for the charity, enabling us to effectively manage the day to day running of the Lost and Found side of our work and ensuring that we are GDPR compliant. During this year we received over 700 submissions of missing or found cats in the area.

Our Facebook page reached 11,000 followers in January 2022 and continues to grow. Our posts for missing cats are shared multiple times across different Facebook pages with vital information being provided and often resulting in happy family reunions.

We are still seeing the results of the Covid restrictions with many callouts to attend abandoned cats who are unneutered and unchipped. This is putting immense strain on all local rescues both financially and physically with limited capacity to take on all these cats. We are fortunate to have a caring cat community in Brighton and the surrounding areas and many members of the public will help to temporarily 'foster' or feed a cat until help is available.

We rehomed 30 cats and kittens and provided accommodation, food and veterinary care for these and the older cats in our care via our network of foster homes and caring volunteers. We continue to fund veterinary care for injured or unwell strays and support financially those owners who struggle to fund emergency veterinary care for their cats. Veterinary costs as ever are our biggest expenditure totalling £31,907, representing just over 80% of our overall annual spend in 2022/23.

Other activities

We received some most generous legacies in the year totalling £130,734 which has considerably boosted our reserve funds. We continue to receive some regular donations from supporters and some individual contributions from grateful families whose cats we have helped to reunite after they have been missing.

As a result of the organisational review of the charity last year, a period of recruitment was undertaken for Lost and Found volunteers and foster carers over the summer of 2022. Five volunteers joined the Lost and Found team and three additional foster carers were recruited. This has strengthened our Lost and Found online service and eased pressures on the existing volunteers. We began advertising for new trustees to join the board in the spring of 2023. Trustee meetings continued to be held virtually since some of our board members were still cautious of in-person meetings following the pandemic.

Volunteers

The Trustees would like to thank all the volunteers and foster carers for their commitment and help over the year and a big thank you to all of our supporters and friends of the charity for their generous and continued support.

FINANCIAL REVIEW

Financial position

Due to the reduction in donations received and the increase in donations made, the charity realised a surplus in the financial year of £115,363 (2022 deficit £18,823).

Reserves policy

It is the policy of the charity to expend its reserves in carrying out its objects, whilst aiming to maintain an appropriate level of reserves where possible to cover any shortfalls in income.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF LOST CATS BRIGHTON

Independent examiner's report to the trustees of Lost Cats Brighton ('the Company')

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 20% on cost

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
