### **TRUSTEES ANNUAL REPORT**

The trustees present their report with the financial statements of the charity for the year ended 31<sup>st</sup> March 2023.

#### **OBJECTIVES AND ACTIVITIES**

The objects of the charity as set out in its constitution are:

1 to relieve persons suffering injury or illness residing in Knutsford, Mobberley and the surrounding area (herein after to be called the area of benefit), by provision of emergency medical care.

2 to preserve and protect health by arranging and supporting emergency life support (els) training free of charge to the general public within the area of benefit.

#### **Achievements and Performance**

After two years of the Covid 19 pandemic restricting activities of the trust, we were able to resume most activities this year.

Nine Heartstart courses were held during the year, with 109 attendees. Attendance levels are much lower than were the norm pre-pandemic, despite the production of new marketing materials and the use of social media outlets.

Two screening days were organised by the Trust and held in association with the charity Cardiac Risk In the Young. 198 people were screened which resulted in five referrals for further investigation.

We now have a total of 40 AEDs, with six added in the year. We continue with 5 volunteers to make monthly checks on all our AED's, advising The Circuit monthly and changing batteries & pads as and when needed.

KCFRT continues to operate a first response service, although the team of First Responders is now down to only three active members.

#### **Public Benefit**

In accordance with their objectives for this year, and with due regard to the published Charity Commission guidance on the operation of the Public Benefit requirements of the Charities Act 2006, the trustees have undertaken appropriate activities in furtherance of these aims for the public benefit.

#### FINANCIAL REVIEW

With the increase in activities there has been a corresponding increase in both income and expenditure. Total funds held at the year end in bank balances amounted to £62,113 of which £20,966 is designated for future cardiac screening events. Receipts and payments in the year are shown on page 7.

Major sources of income came from the Delamere Foundation, Booths' sponsorship, donations via CAF, Bev Devereaux's various fundraising events and of course Terry's amazing recycling activities!

#### RESERVES POLICY

KCFRT has not yet adopted a formal reserves policy.

#### STRUCTURE, GOVERNANCE AND MANAGEMENT

##### Governing Document

The charity is unincorporated and governed by its constitution adopted 4 January 2006 and amended 14 May 2007 and 21 May 2018.

#### HOW DOES THE CHARITY OPERATE?

The Knutsford Community First Responder Trust acts as an umbrella for four initiatives.

- **First Responders:** a group of volunteers who are trained by and work with the North West Ambulance Service. Their aim is to preserve life and promote recovery in an emergency before the ambulance arrives. The team works in conjunction with the ambulance service to provide a rapid response to emergency situations. When a member of the public dials for an ambulance in the Knutsford area, the Duty First Responder is also advised of the call and is asked to attend.
- **Defibrillators:** an initiative to provide and manage the upkeep of Community Public Accessible Defibrillators (CPADs) and Automatic External Defibrillators (AEDs) in and around the Knutsford area.
- **Heartstart:** the aim of which is to teach Emergency Life Support Skills, free of charge, to as many members of the public who would like to learn.
- **Cardiac Screening:** offering cardiac screening to the young people of Knutsford in association with the charity Cardiac Risk in the Young (CRY). Cardiac screening involves providing ECGs and Echocardiograms to young people between the ages of 14 & 35.

Each initiative has a member of the KCFRT committee nominated as the “Lead” person responsible for organising and reporting on the activities undertaken to support the initiative. These leads, plus the Treasurer form the executive committee. Executive committee meetings normally take place 3 times per year, with an additional Annual General Meeting.

#### Risk Assessment

The Trustees have carried out a detailed review of the charity's activities and produced a comprehensive plan setting out the risks to which it was exposed. A strategy has been implemented to establish systems and procedures to mitigate those risks identified. These will be reviewed annually.
