The trustees believe that reserves of £169,771 are sufficient as it has very little administrative expenses and does not have any binding future commitments.



### 1 ACCOUNTING POLICIES

#### **Basis of accounting**

The financial statements have been prepared under the historical cost convention and in accordance with applicable United Kingdom accounting standards, the Statement of Recommended Practice "Accounting and Reporting by Charities" issued in March 2005 (SORP2005) and the Charities Act 2011.

#### **Donations receivable**

#### **Donations payable without performance conditions**

These are only recognised in the accounts when a commitment has been made and there are no conditions to be met relating to the donation which remain in the control of the charity.

The charity donations have been detailed in note 4 to the financial statements.

### **FUND ACCOUNTING**

General unrestricted funds comprise the accumulated surplus or deficit on income and expenditure account. They are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity.

Restricted funds are funds subject to specific restricted conditions imposed by donors. There are no restricted funds as at the Balance Sheet date.

Designated funds are funds which have been set aside at the discretion of the trustees for specific purposes. There are no designated funds as at the Balance Sheet date.

### **RESOURCES EXPENDED**

#### **Liability recognition**

Liabilities are recognised as soon as there is a legal or constructive obligation committing the Charity to pay out resources.

#### **Support costs**

Support costs are those costs which are common to all areas of the organisation. These are allocated across all areas of activity using a method which would be appropriate to the type of expense.

#### **Governance costs**
