Structure, Governance and Management

The governing document is by trust deed. The charity is constituted by trust and W K Olford, A M Olford and A D Grigg were appointed trustees on the adoption of the constitution on 26 July 2007. New trustees are appointed by resolution of the existing trustees passed at special meeting. Dr M J Ashleigh was appointed a trustee on 8 August 2017.

History

The group, 'Friends of Ebenezer Child Care' has supported orphans at Ebenezer Trust School in the town of Livingstone, Zambia since 2005. On 26 July 2007 the group was formally constituted by trust deed and was registered by The Charity Commission for England and Wales on 8 August 2007. The charity's number is 1120502.

Objectives and Activities

To relieve poverty and protect the good health and advance education of orphaned and vulnerable children in the Ebenezer Child Care Centre, Livingstone, Zambia.

Activities include giving presentations to organisations such as schools, churches and clubs in the UK to encourage them to hold fundraising events that will enable donations to be given on a monthly basis into the designated bank account.

Achievements and Performance

The trustees have successfully raised funds towards the running costs of the school and homes.




