Activities: Clubs, away breaks and one-off events for people of all ages and ethnic backgrounds. Serves socially-deprived communities, reaches out to poor, disadvantaged and vulnerable people and fosters sense of inclusion and belonging. Provides a stepping stone from lives of struggle and despair to lives of fulfillment and hope; introduces people to the life-changing impact of the Christian message.
