PROMOTING, IMPROVING, DEVELOPING, ASSISTING, MAINTAINING, SUPPORTING AND COOPERATING WITH ANY OTHER CHARITABLE OR OTHER BODY WHICH THE COMMITTEE MAY FROM TIME TO TIME DECIDE TO SUPPORT.
