Objects: OBJECTS3. THE CHARITY'S OBJECTS ("THE OBJECTS") ARE FOR THE BENEFIT OF THE PUBLIC GENERALLY AND, IN PARTICULAR, THE INHABITANTS OF LONDON, BUCKINGHAMSHIRE, SOUTH OXFORDSHIRE, EAST BERKSHIRE, HERTFORDSHIRE AND THEIR SURROUNDING AREAS:-3.1 TO PROMOTE COMMUNITY PARTICIPATION IN HEALTHY RECREATION BY PROVIDING FACILITIES FOR THE PLAYING OF RUGBY UNION AND OTHER SPORTS CAPABLE OF IMPROVING HEALTH (" FACILITIES" IN THIS CLAUSE 3 MEANS LAND, BUILDING, EQUIPMENT AND ORGANISING SPORTING ACTIVITIES);3.2 TO PROVIDE AND ASSIST IN PROVIDING FACILITIES FOR SPORT, RECREATION OR OTHER LEISURE TIME OCCUPATION OF SUCH PERSONS WHO HAVE NEED FOR SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, POVERTY OR SOCIAL AND ECONOMIC CIRCUMSTANCES OR FOR THE PUBLIC AT LARGE IN THE INTERESTS OF SOCIAL WELFARE AN WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE; AND 3.3 TO ADVANCE THE EDUCATION OF CHILDREN AND YOUNG PEOPLE THROUGH SUCH MEANS AS THE TRUSTEES THINK FIT IN ACCORDANCE WITH THE LAW OF CHARITY.

Activities: THE CHARITY PROMOTES THE EDUCATION, MOTIVATION AND INSPIRATION OF PEOPLE THROUGH THE POWER OF SPORT IN PARTICULAR THE ADVANCEMENT OF EDUCATION, THE PROTECTION OF GOOD HEALTH BOTH MENTAL AND PHYSICAL AND THE RELIEF OF POVERTY, DISTRESS AND DIABILITY OR SICKNESS AND SUCH OTHER EXCLUSIVELY CHARITABLE PURPOSES WHICH ARE OF BENEFIT TO OUR COMMUNITIES.
