Charity Objectives and Activities

The Coronation Hall was established in 1937 as a community facility "for the benefit of the inhabitants of the Parish of Water Eaton". Its formal governing document is a Deed of Trust dated 15 October 1937, which sets out the core purpose for which the Hall may be used:

"The Coronation Hall is held upon Trust for the purpose of physical and mental recreation and development through the medium of reading and recreation rooms, library, lectures, classes, and recreations for the benefit of the inhabitants of Water Eaton and its immediate vicinity."

Activities beneficial to local residents and the wider community over the past 12 months have included:

- Line Dancing
- Karate
- Tai Chi
- Sequence Dancing
- Sunday Prayer meetings
- Diabetes Prevention programme
- Polling Station

Achievements and performance

- Health & Safety Action Plan completed including Legionella risk assessments, reintroduction of Fire evacuation drills and replacement of 2 fire extinguishers.
- All servicing and regular health and safety checks implemented.
- The archive stored within the hall updated to include all known historical documents.
- Original legal documents dating back to 1937 passed to Geoffrey Lever Solicitors, with copies also held in safe storage by the Town Council.
- Professional advice sought about the physical condition of the premises and priorities to include in a 5-Year Capital Expenditure Plan.
- Lighting in the foyer and toilet areas replaced with 10w LED fittings
- New more energy-efficient central heating control system installed
- Cooker replaced.
- Policy documents including Booking Forms, Standard Conditions of Hire and website updated.

Financial review

The enclosed Receipts and Payments Accounts for the year ending 30 September 2022 show the Coronation Hall's position at the end of the Financial Year.

Structure, governance and management

When the Coronation Hall became a registered charity in 2010, a second document was drawn up in agreement with the Charity Commission, clarifying the responsibilities of the Management Committee in implementing the original Trust Deed in the context of prevailing statutory and other requirements. This document includes the Aims, Objectives, Composition and Appointment of the Management Committee, in furtherance of the requirements of the 1937 Trust Deed.

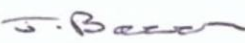
