Havering Music School is the specialist music service for the London Borough of Havering and the lead organisation for the Havering Music Education Hub.

The Friends of Havering Music School (FoHMS) was created in 2006 by parents/guardians of children studying there at that time with the aim of supporting the Music School and its students.

All funding requests are subject to approval by the FoHMS trustees and disbursements are dependent on the presentation of invoices or receipts.

Our objectives are to advance the education of children and adults studying at the Havering Music School by providing equipment, facilities and financial support and to make music tuition available to more people within the London Borough of Havering, especially young people whose lives may be enriched by the experience.

Funding the purchase, maintenance, repair or installation of musical instruments. Funding the purchase of other music related equipment and sheet music for Music School ensembles.

Sponsorship to help students in need to continue their studies at the Music School and (occasionally) grants to help students continue their music tuition after leaving the Music School.

Funding activities and initiatives to encourage young people across the London Borough of Havering to take an interest in music making and music studies.

In planning our activities and when considering requests for funding the trustees have had regard to the guidance issued by the Charity Commission on public benefit.

In April, £37,681 was donated to our general fund following the closure of the Havering Schools Music Association (HSMA). In return it was agreed that FoHMS in conjunction with Havering Music School would continue to support the HSMA's objective to encourage and facilitate musical activities within and between all schools and education centres in the London Borough of Havering. To this end, a committee has been set up by the Music School including representatives from local primary and secondary schools which together with FoHMS will develop a programme of activities going forward, accounted for under the category 'Music for Schools'.

We are entirely reliant on volunteers and are grateful for everything they do. We value the good working relationship we have with Music School staff in pursuit of our objectives as a charity and are grateful for their help in facilitating the Saturday Tuck Shop (see Section E).

**Summary of the main achievements of the charity during the year**

In accordance with our objectives we funded the following items:

£903 for the purchase of ten DJ decks, mainly used at the Music School's Wednesday DJ Club and Summer School sessions. Two of the decks were situated at local libraries to provide wider public access.

£3,320 for the purchase of 12 month unlimited access licences from Play Virtuoso for eight Havering Secondary Schools, providing access to 300+ hours of video courses from professional producers, DJs and songwriters covering modern music making techniques. This was a one-off purchase made on the understanding that the schools concerned would be responsible for then renewing their licences and at the time of writing we understand that at least six schools intend to renew for a further 12 months.

£384 for the purchase of 31 violin bows of various types, £462 for the refurbishment of a grand piano donated to the Music School and £183 for the purchase of sheet music.

£5,400 was provided to the Music School to cover the initial costs of staging a two day Junior School Singing Festival at the Queen's Theatre, Hornchurch in June. This was a continuation of the festivals previously organised by the HSMA prior to the Covid pandemic. We anticipate that after ticket sales have been taken into account and VAT has been recovered, a modest surplus will be generated to help fund further Music for Schools initiatives in future periods.

£1,206 was spent on subsidising Music School lessons for five students for varying periods over the 2022/23 school year. The students concerned came from families who were experiencing financial difficulties and we were pleased to be able to help them continue their music studies.

Part of our general fund is held by the Churches, Charities and Local Authorities (CCLA) Investment Management Ltd. These funds are held in an interest bearing account.

Our principal source of funds are:

1. Donations, including those from individuals, charity fund raising organisations such as the PayPal Giving Fund and from cash collections at events such as Music School concerts.
2. A Tuck Shop run by volunteers at the Saturday Music School sessions providing refreshments for students and their parents/guardians. The Tuck Shop is financially self-sufficient with the income from sales fully covering the cost of stock. Any surpluses are used to support our charity objectives with £1,748 contributed to our funds from a turnover of £5,562 over this reporting period



## Section F Other optional information



