<p>Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.</p>	<p>We have provided daily education, food and care to 110 vulnerable and orphaned children living in rural poverty in Western Kenya. We have built and resourced school and community buildings/facilities. We have provided advocacy/ advice/ information to the local community focussing on health and welfare issues, domestic abuse support, basic financial management workshops and agricultural/animal husbandry best practice. We have provided services including education, vocational training and first aid to the school and local community. We have extended and maintained a poultry farm, providing food for orphans and income to fund our core activities. We have made small grants to individuals classed as in extreme poverty and/or need. We have provided Human Resources including teachers, social workers, water and aid professionals. We have acted as an umbrella/resource body for the local community, particularly women needing support or lacking agency and have signposted when necessary.</p>

Policy on grant making	Grant Making is restricted to below £350 per family. Need assessments are carried out by in-country staff and a quarterly sign off by 5 Trustees is required. We made grants totalling £475 for the miner families impacted by Abimbo mining accidents.
Policy on social investment including program related investment	A majority of Trustees are required to be in support of any investment or significant change program. The main social investment programs are capacity building and resourcing for education and women’s enterprise training and developing local poultry farming.
Contribution made by volunteers	2 UK Trustees have volunteered 7 professional work hours each a week for a year (728 hours) whilst other volunteers have been involved in web design and maintenance, child protection and safeguarding, donor support, partner collaboration and impact measurement. We have continued to grow and develop our Kenyan volunteering successfully with 4 local volunteers cooking food and cleaning for the orphaned children each day. We also train volunteers to help with the dressmaking projects and community resilience workshops.

<p>Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.</p>	<p>This year, we are proud our team managed to adapt so quickly to the Covid-19 outbreak and subsequent lockdowns and restrictions. Restructuring the dressmaking project to produce PPE within a week was a real achievement. The team instantly adapted to provide safe care, food and emergency assistance to child headed households who needed support when the school was closed. Staff took a significant pay cut as funds became more tight and took on extra duties to ensure the charity continued to help as many beneficiaries as before but with less resources.</p> <p>In response to a lack of clean water and soap, families were encouraged to use the community and school facilities at various set times and were donated rain water collection tanks, buckets, hand soap, sanitiser and masks. Training was given and Covid-19 awareness raising sessions educated those who misunderstood the disease. We spent £1387 on rain water collection tanks and gutters. The school adapted to social distancing immediately despite limited resources and building space. We have built a new classroom costing £4385 and provided tables and chairs for 60 children, costing £851.</p> <p>Our Kenyan team have been resourceful, resilient and responsive. The community poultry project has grown more sustainable despite numerous challenges ranging from drop in customer demand to difficulties sourcing chicken feed and medical supplies.</p>
