Other		From its humble beginning in 2002, Creation Fest has continued to grow and receive widespread support and interest from across local and national communities, churches, charities and organisations. Starting as a one-day festival on the Esplanade in Woolacombe in 2002, then a three-day event from 2003 – 2008 (Woolacombe). In 2009 it moved to the larger county showground in Wadebridge, Cornwall, to host a seven-day event each summer. Yet despite its success and growth over the last twenty years, the nature and format of the festival has kept its missional heart for Christian outreach and ministry. In 2007 it became a registered Charity. After a year of rest for COVID (2020) it returned as a three day festival in 2021 and a four day festival in 2022.

Independent examiner's report to the Trustees of Creation Fest Limited.

I report to the charity trustees on my examination of the accounts of the company for the year ended 31st October 2023, which are set out on pages 1 to 51.

Responsibilities and basis of report

As the charity's trustees of the company (and also its directors for the purposes of company law) you are responsible for the preparation of the accounts in accordance with the requirements of the Companies Act 2006 ('the 2006 Act').
