D) STROKE REHABILITATION UNIT OF HM STANLEY HOSPITAL, ST ASAPH BEING A CHARITY, THE CHARITY NUMBER BEING 1047989. E) SUCH OTHER CHARITIES AS ARE ADDED UNDER CLAUSE 2.
