Events manager, Music Director, Publicity officer, Recruitment officer, Secretary, Chairperson and Treasurer

The Officers shall be elected by and out of the Choir's members at the Annual General Meeting; they shall hold office until the next Annual General Meeting and be eligible for re-election according to the rules of governance. The Board are the charity trustees."

Under the rules of governance the Music Director is exempted from having to seek re-election.



5. Public benefit statement



We confirm that we have complied with our duty to have due regard to the guidance on public benefit published by the Commission in exercising our powers or duties. We have carried out the objects of the Choir's constitution by carrying out the activities described below.

i. To advance, improve, develop and maintain public education in appreciation of choral music by promoting the study, practice and performance of such music.

We held regular weekly rehearsals throughout the year, together with several additional rehearsals for special events. We added a number of new pieces to the choir's repertoire (all original arrangements), while perfecting our existing repertoire.

During the year we gave 12 public performances mainly in and around the Swansea area but also including 2 performances on our tour of Salamanca.

We also undertook 5 private engagements (mainly weddings and funerals).

Several new choristers joined during the year, along with some resignations but our numbers were maintained above 30.

ii. To preserve and promote the heritage of Welsh male voice choral singing by educating young people in those traditions.

Our Music Director has continued to develop a repertoire of modern popular music to appeal to a young audience, while also introducing them to traditional Welsh male choir pieces. The choir has consistently worked to live up to its reputation as the "choir with a difference".

iii. To support charitable causes.

The choir undertook several concerts in support of charitable causes. We made a donation to Ty Olwen.
