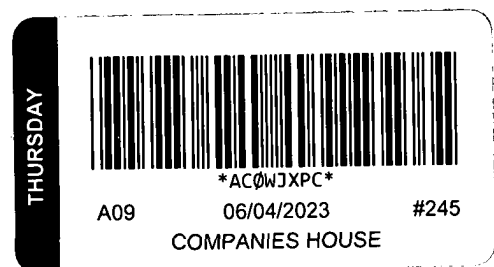

**Report of the Trustees
for the Year Ended 30 June 2022**

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 30 June 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

Objectives and activities

Objectives and aims

To promote, maintain, improve and advance education, particularly by the production of educational concerts and plays and encouragement of the arts, including in particular the art of music and to formulate, prepare and establish schemes therefor.

Public benefit

In line with the Charities Act 2011, the Charity Commission for England and Wales issued guidance on the criteria it uses to determine whether or not a charity provides public benefit. We have considered the guidance and are satisfied we provide considerable public benefit as detailed in this report.

Achievement and performance

Charitable Activities

The activities of the Orchestra have been very limited throughout this year. This has been due to lack of funding. However, the Orchestra has been fortunate enough to perform as part of 'Fever Candlelight Concerts performing from November 2022 onwards. We have performed programmes of music composed by Hans Zimmer, Queen, Vivaldi Four Seasons and Concerts of Christmas music, in wonderful venues around Cardiff including Llandaff cathedral.

In the current year we are developing our Castle Concerts project. Concerts in the Castles of Wales. We hope to tour various Castles around Wales promoting classical and modern repertoire, hospitality and the Castles themselves. We hope to perform educational and relaxed concerts so that the music can be enjoyed by everyone.

Whilst able to perform live only occasionally, the Orchestra has continued to have a good presence and hopes to continue this in the following year, as well as performing live more often and supporting our freelance musicians and continuing our vital work within the community and education.

Financial review

Financial position

The charity generated a deficit for the year of £8,593 (2021: surplus of £7,603). As at the 30 June 2022 the charity held restricted funds of £1,247 and unrestricted funds of £2,468.

Currently, the orchestra has no debts and has a reserve amount thanks to a £10,000 grant from Wales Cultural Recovery Fund.

Reserves policy

The charity has no fixed costs or regular expenses. Trustees consider that it is appropriate to minimize risk by maintaining free reserves sufficient to cover at least any expenditure to which the charity is contractually committed. The only contractual commitment within the financial statements at the year end totalled £1,089 as disclosed within the balance sheet. Free reserves at the year end totalled £2,468. The Trustees will seek to build free reserves over a number of years as the orchestra's activity expands.

Structure, governance and management

Governing document

The charity is controlled by its governing document, the Memorandum and Articles of Association, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Recruitment and appointment of new trustees

Appointment of trustee and directors is by invitation from the board.

Independent examiner's report to the trustees of Ensemble Cambrica Ltd ('the Company')


The members have not required the company to obtain an audit of its financial statements for the year ended 30 June 2022 in accordance with Section 476 of the Companies Act 2006.

Notes to the Amended Financial Statements for the Year Ended 30 June 2022

1. Revised financial statements

The financial statements for the year ended 30 June 2022 have been amended.

They

- replace the original financial statements;
- are now the statutory financial statements;
- are prepared as they were at the date of the original financial statements and not as at the date of revision and accordingly do not deal with events between those dates.

2. Accounting policies

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Government grants

Government grants relate to income received from the Welsh Government's Wales Cultural Recovery Fund (WCRF).

3. Trustees' remuneration and benefits
