A new project is being researched to develop a link between the established Kindergarten and more remote villages schools where teachers are untrained and resources are minimal.

In keeping with the development undertaken, the Kindergarten will now be known locally as the Immanuel Kindergarten and Primary School.

The significant grant obtained from the Community of St Denys, which has now provided funds of £41,107 has enabled the construction of the new classrooms in South Sudan. The building was officially opened on 17 December 2022.

Significant items of income in the year included the second building grant receipt from St Denys, £11,107 and donations, including gift aid, of £23,226. Of this, £12,500, including gift aid, was generously donated by Dr Pamela Goode. A donation of £1,300 was received from 'Roots Sudan' in respect of bookshop equipment. £1,268 was spent on purchasing this equipment.

Building and renovation costs of £23,672 were expended and donations of £2,078 were made towards staffing costs.




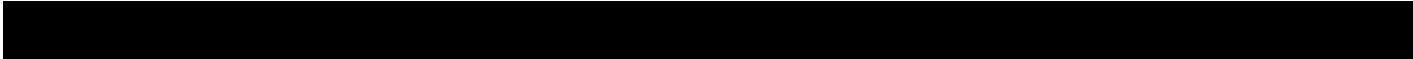

Summary of the main achievements of the charity during the year

The significant grant obtained from the Community of St Denys, which will be £41,107 in total has enabled the commencement of the building of new classrooms in South Sudan. A very successful '15th anniversary celebration' abseiling event arranged by Carolyn Murray also raised £6,646 for Immanuel.

The success of the year was marred by the untimely death of Immanuel school headmaster, Malish Simon, in January 2022.

Significant items of income in the year included the interim grant receipt from St Denys, £30,000, the abseil event, £6,646, Donations including gift aid, £5,696 and the bookshop, £3,600.

Funds of £29,998 were applied for the new school classroom construction together with donations towards a number of other essential resources. These included a generator, £2,656, photocopier, £1,025, a solar panel, £750 and £299 for a laptop for school administrative purposes. An amount of £677 was donated for staff training, £1,449 for office and banking set up costs and £745 for flour and other basic needs.




