CONSTITUTION, OBJECTIVES AND POLICIES

Accounting Policies

Basis of Accounting

The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities (SORP 2005) issued by the Charity Commission. Restricted funds are subjected to restrictions on their expenditure imposed by the donor or contained in the terms of a grant.

Tangible Fixed Assets

Depreciation is provided at 25% musical equipment and 25% on motor vehicle calculated to write off the cost of asset on a straight-line basis.
