Members of the EC and volunteers attended training in financial procedures to ensure that they are familiar and have up to date knowledge on current and new financial procedures such as Statement of Recommended Practice (SORP).

We are grateful to our donors, funders for funding over the past two years. We are grateful to the funders i.e Big lottery Community Funds, LLOYDS bank, HM Government Furlough - to cover wages for employees on temporary leave ('furlough') due to coronavirus (COVID-19) for their support during the pandemic.

Advice and Information Service during the Covid 19, Pandemic.

The service aims to offer mainly advice and information in order to seek the relief of poverty and distress through providing information service that is free, confidential, impartial, and independent and promote clients' confidence in obtaining their entitlement.

Minority ethnic communities have multiple disadvantages due to extreme of poverty and its consequences are featured in poor health, housing, unemployment and under achievement in education.

The advice session is designed to inform and advice users of their entitlement to a range of benefits and services with particular emphasis on welfare benefits, housing, nationality, immigration, racial harassment, domestic violence, disability rights and family problems.

We provide support and recommend referral services to citizen advice bureau, UKAIS and other providers for representation to users at tribunals, arbitration and review panels. The advice service also promotes the knowledge and confidence of users in exercising their rights and obtaining services available to them in the area in order to influence policy and procedures relating to issues arising out of case work. We train and support volunteers in order to equip them with necessary skills and expertise in furthering the objects.

Homework Tuition Classes

Boys and girls of all ages who would like supplementary tuition in mainstream subjects or mother tongue will benefit from our classes or enjoy our social or cultural activities during the pandemic virtually.

We provide all levels of tuition- from complete beginners through GCSE to A level- in English, Maths and Science, as well as Bengali language and literature. Our teaching is carried out in small groups so that the children can receive the individual attention they need.

A level tuition is carried out by teachers with experience of working in sixth form and further education colleges virtually.

We work closely with mainstream schools in the area to ensure that our courses meet the requirements of the curricula we teach.

The two tutors and volunteers run classes two days a week

Saturday and Sundays 10 to 12noon virtually during the pandemic. This service is vital for children to raise their achievement levels in mainstream education. At present there is a waiting list of 10 children, with parents very anxious for their child/children to attend these classes.

Ex Offenders Project:

- NEKH young offender inclusion project is aims to work for the targeted Young offenders who are marginalized in the community and need help and support in order to integrate in the mainstream community. The activities are designed to boost up their moral and assist them in integrating with the mainstream society particularly socialize with the family, friends and local community and remove stereotype views among the family and local community members about their sentencing period in prison. The activities will help to overcome traumatic experience, socialize in the society and engage in to develop a positive vision for future life.
- The project will try to engage Young offenders in learning the knowledge, skills and understanding to become informed and thoughtful citizens who can be effective in society at local, national and global levels;
- Stimulate their 'sense of responsibility, as they will become aware of their duties and rights;
- Foster and develop their 'respect for the community in which they are living and behave accordingly;
- Encourage them to play an effective role in society by ensuring that they can participate in active citizenship and become helpfully involved in the life of their neighbourhood, communities, and the wider society during the Covid 19, pandemic.
