Para 1.20	<p>January 2023 began with an air of enthusiasm. The charity embarked upon the purchase of their first property in the UK, Tyddyn Y Pwll in Wales, a retreat facility with a farm house, two small cottages and workshop space. The initial down payment was made at the end of January and the completion was finalised on the 28th March. We moved in furniture and equipment and began to repair, refurbish, arrange and organise the space, to make it suitable for the first festival held on the 23rd April. We thereafter began to have monthly Bhakti retreats/festivals. On the 19th May we hosted and facilitated for a group of yoga practitioners to hold a retreat at the property and continued to host retreats like this about once a month. The opportunity of owning a retreat centre is a long cherished desire of the charity. We are then able to invite members of the community and guests to have the opportunity to take time out of life and be able to immerse themselves in a retreat environment and have time to meditate and reflect on themselves and the deep esoteric philosophy of the Veda. In this way people have told us that they go back more energised and empowered and positive. Not to mention being in a clean environment with pure air and water and food.</p> <p>The programs in London have been going on nicely especially the nama-hatta outreach</p>

		<p>programs have had a lot of positive feedback. The regular Sunday Sat sang was cancelled with more emphasis going to the nama-hatta programs instead. Kirtan programs have been giving a lot of positive energy into the community. We have been giving out blessed food on the street and in the markets with a lot of happiness from the members of the community and have been encouraged to continue with people giving donations to help with the costs. Yoga programs have picked up a lot in popularity on line with a steady amount of classes available. We honoured the travelling guests with arranging hall programs and festivals for them. These prove to be extremely popular events attracting people from all over the UK and abroad. All in all a very positive year with a lot of new avenues to explore and expand the field of our activities in accordance with the charities aims and objectives.</p>

That makes a net income of £185,000.</p> <p>The funds from the previous year were about £280,000. We bought the property in Wales at a value of £900,000 and the charity took a mortgage of £630,000.</p> <p>At the end of the year the charity paid off £100,000 from the mortgage.
