Activities: 1) To benefit the inhabitants of the Peniel and Rhydargaeau areas by associating with the local inhabitants, local authority and voluntary organisations to advance education, social welfare, recreation and leisure time occupation in order to improve the lives of the said inhabitants;2) To establish and manage a community centre;3) To promote other charitable purposes as appropriate.
