TO ADVANCE THE EDUCATION OF UNDER-PRIVILEGED CHILDREN IN THE SCHOOL'S LOCAL COMMUNITY BY PROVIDING EDUCATIONAL SPONSORSHIPS. TO PROMOTE SUSTAINABLE DEVELOPMENT FOR THE BENEFIT OF THE PUBLIC BY THE RELIEF OF POVERTY AND THE IMPROVEMENT OF THE CONDITIONS OF LIFE IN SOCIALLY AND DISADVANTAGED COMMUNITIES BY THE PROMOTION OF SUSTAINABLE MEANS OF ACHIEVING REGENERATION. 'SUSTAINABLE REGENERATION' MEANS 'DEVELOPMENT' WHICH MEETS THE NEEDS OF THE PRESENT WITHOUT COMPROMISING THE ABILITY OF FUTURE GENERATIONS TO MEET THEIR OWN NEEDS.
