The charity was established by Trust Deed dated 14 June 2008 and registered with the Charity Commission on 14 July 2008 – charity number 1124971. All Trustees are required to declare their belief in and allegiance to the Trust's Statement of Beliefs. New Trustees may be appointed by a resolution of the Trustees passed by a majority of the Trustees.

Objects of the Trust

To advance the Christian faith in accordance with the Trust's Statement of Beliefs in the UK or the world. To relieve sickness and financial hardship and to promote and preserve good health by the provision of funds, goods or services of any kind, including the provision of counselling and support in the UK or the wider world.

Review of Activities

The Trust has made steady progress. The three main areas of activity listed below have been further developed.

1. Bible Schools
2. Support to pastors, missionaries and churches
3. Support for those working on behalf of the Jewish people

The Trustees have complied with their duty to have due regard to the guidance on public benefit published by the Commission in exercising their powers or duties.

Achievements & Performance

This has been a steady year with work and services provided along similar lines to previous years. A pattern of ministry is now well established and continues to be appreciated by those who benefit from the Trust.

The level of preaching and teaching in UK churches has shown a slight decline this year but much increased via podcasts in various churches in Africa through our work

with African Pastors Fellowship. Moral and spiritual help to church leaders has continued as they experience the ongoing stress of a post-pandemic world. The provision of prayer and fellowship gives perspective and reduces isolation and is much appreciated.

The Trust continues its international perspective through financial assistance to the charity Ezra UK, fostering work supporting Jewish people especially in Eastern Europe; and similarly to the work of the charity African Pastors Fellowship, fostering Clergy support in East Africa. The moral and spiritual support to Christian organisations and churches working in the Ukraine continues.

Financial Review

The Trust is committed to applying £1,000 of its income from preaching/teaching to a Gifts Fund to support pastors and missionaries. At 31st March 2025 this money had been spent and so there is no reserve for this purpose.

The Trust has a financial reserves policy to hold a sum in reserve which would cover three months operating costs and at 31st March 2025 the sum of £6,000 was held in reserve for this purpose.

The Trust does not hold funds as custodian trustee on behalf of others.

The primary source of funding for the Trust comes from voluntary income. Other income is generated from preaching and teaching carried out on behalf of the Trust by Revd Andrew Kane.





The Trustees have complied with their duty to have due regard to the guidance on public benefit published by the Commission in exercising their powers or duties.

Achievements & Performance

This has been a steady year with work and services provided along similar lines to previous years. A pattern of ministry is now well established and continues to be appreciated by those who benefit from the Trust.

The level of teaching and preaching in Anglican and Baptist Churches remains similar but one area that has seen growth is that of moral and spiritual support to Clergy and

Church leaders. Church leaders have been under increased strain through and following the years of the pandemic. Stress among such remains high so the Trust has provided support through fellowship and prayer. The provision of this, which gives perspective and a reduced sense of isolation, has been much appreciated.

The Trust continues its international perspective through financial assistance to the charity Ezra UK, fostering work supporting Jewish people especially in Eastern Europe; and similarly to the work of the charity African Pastors Fellowship, fostering Clergy support in East Africa. The moral and spiritual support to Christian organisations and churches working in the Ukraine which began last year continues.

Financial Review

The Trust is committed to applying £1,500 of its income from preaching/teaching to a Gifts Fund to support pastors and missionaries. At 31st March 2023 this money had been spent and so there was no reserve for this purpose.

The Trust has a financial reserves policy to hold a sum in reserve which would cover three months operating costs and at 31st March 2023 the sum of £7,000 was held in reserve for this purpose.
