**Objects:** A TO ADVANCE EDUCATION BY SUCH MEANS AS THE TRUSTEES MAY CONSIDER APPROPRIATE INCLUDING (BUT NOT SO AS TO LIMIT THE GENERALITY OF THE FOREGOING) BY THE EDUCATION OF ORPHANS WIDOWS WIDOWERS AND SINGLE PARENTS IN DEVELOPING AND DEVELOPED COUNTRIES SO AS TO PROMOTE SOCIAL JUSTICE EQUALITY AND WELL BEING OF PEOPLE AND THE EDUCATION OF THE GENERAL PUBLIC THROUGHOUT THE WORLD ON ISSUES OF POVERTY ILL HEALTH AND INJUSTICE EXPERIENCED BY ORPHANS WIDOWS WIDOWERS AND SINGLE PARENTS IN SUCH PARTS OF AFRICA, THE UNITED KINGDOM OR THE WORLD AS THE TRUSTEES MAY FROM TIME TO TIME THINK FIT AND TO FULFIL SUCH OTHER PURPOSES WHICH ARE EXCLUSIVELY CHARITABLE ACCORDING TO THE LAW OF ENGLAND AND WALES AND ARE CONNECTED WITH THE CHARITABLE WORK OF THE TRUSTB TO RELIEVE SICKNESS AND FINANCIAL HARDSHIP AND TO PROMOTE AND PRESERVE GOOD HEALTH BY THE PROVISION OF FUNDS, GOODS OR SERVICES OF ANY KIND, INCLUDING THROUGH THE PROVISION OF COUNSELLING AND SUPPORT IN SUCH PARTS OF AFRICA THE UNITED KINGDOM OR THE WORLD AS THE TRUSTEES FROM TIME TO TIME MAY THINK FITT
