Structure, Governance and Management

Structure

Wealden Sailability is a registered charity (1125286) which was established on 24th July 2008 as Bough Beach Sailability but changed to its present name on 9th May 2011. The charity is governed by a Trust Deed and managed by the Trustees. These accounts cover the period from 1st March 2022 to the 28th February 2023.

Appointment of Trustees

In accordance with the Trust Deed, the Board must consist of a minimum of 3 Trustees. The appointment of Trustees is made by the unanimous decision of the Trustee Board having taken into account relevant and complimentary skills, experience and knowledge enabling them to assist in the successful management of the charity. A Trustee is appointed for 3 years of service and after that period is eligible for reappointment.

Organisation

Administration of the affairs of the charity are conducted by the Board of Trustees which meets at least once a year and as required throughout the year.

Risk Management

The Trustee Board is responsible for the assessment of the major risks to which the charity, its volunteers, sailors, carers and general public might be exposed. This particularly applies to the charity's operations, finances and safeguarding. All policies are published on the charity's website enabling access by any interested parties.

Objectives and Activities

Wealden Sailability (WS) is a registered charity to provide or assist in the provision of sailing facilities for recreation or other leisure time occupation for people with disabilities with the objective of improving their condition of life in particular but not exclusively by:

- Coaching, recreation, and, where appropriate, competitive opportunities in sailing for disabled people in the local community and from such other areas as may be determined from time to time.
- Providing an introductory methodology whereby a disabled sailor might be accommodated within the normal operations of a sailing club.

Presently, there is a client base of over 400 disabled people. Any person of any disability, gender, age and background are welcomed to partake in the activities offered.

Sailing sessions are held on a Tuesday and Thursday from April to the end of October.

The charity is primarily financed by charitable donations. There are 27 dinghies ranging in size and all are designed or adapted for disabled sailing. In addition there is a motor boat capable of taking a number of wheelchair users. The charity is fortunate in that it is hosted by the Chipstead Sailing Club which enables a sharing of facilities, the storage of dinghies

and the use of rescue boats and equipment. Charges are made for these services by the sailing club.

There are no paid employees. The charity is reliant on a team of more than 80 volunteers to assist our disabled sailors and carers.

Appropriate training is given to volunteers who are sailing and those selected for the safety rescue boat squad

Participants are encouraged to sail independently, become involved in the weekly racing and to develop their sailing skills. For those unable to sail, the charity has a motor boat which is directly accessible by wheelchair users.

Achievements and Performance

General Overview

The 2022 season saw another increase in the number of sessions held as the recovery from the Covid-affected seasons of 2020 and 2021 continued. The first client sessions were still delayed until May to allow more time for the training of volunteers. As a result, the overall numbers of clients sailing with us for the year were still lower than 2019 but attendance by both clients and volunteers grew as confidence returned.

The major development for the year was the acquisition and fitting out of a dedicated workshop / storage shed for the exclusive use of WS. This was funded from donations from a number of sources and particularly included a crowdfunding initiative for the first time that was supported by a large number of individuals, including many volunteers, with matched funding from Crowdfund Kent. The benefit has been clearly demonstrated over the winter season, allowing maintenance work on the fleet of boats to be carried out in very much better conditions, largely unaffected by the cold and wet weather.

Much good work has also been carried out to improve the structure and effectiveness of our training for both client sailors and volunteers. A more structured and documented training programme is particularly attractive to the school and youth groups who attend and we are confident that this will help rebuild relationships with these types of organisation who have, in some cases, been slower to return post-Covid.

Financial Review

Wealden Sailability remains financially secure and there is a healthy total cash fund of £23,777 of which £15,008 is contained in designated funds.

Operational expenditure increased to £10,509 with the major expense being £4,467 for boat maintenance and equipment. Asset purchases were very much higher this year at £17,777 mainly related to the new workshop and the acquisition of two Hansa 2.3 sailing boats.

Historically, most of the funding comes from donations while all disabled client sailors participating are asked to contribute a very modest £3 per session. This amounted to £4,119 in 2022, more than double the 2021 figure as numbers rebounded.

Total income from donations was very much higher at £21,695 after the successful crowdfunding campaign for the new workshop and numerous other generous donations.

In common with the rest of the country, WS are not immune to the effects of 'cost of living crisis' and we have to face increased costs in many elements of our operation. This includes, following a review of the insurance arrangements, a decision to increase the sums insured for the boats significantly to reflect more closely the likely cost of replacement in the event of loss. Overall, the net effect is that the Strategic Reserve (see below) has had to be increased.

In addition, the fleet of boats is aging and significant work is planned to have professional refits carried out on the majority of them. We trialled this with two boats and the results have been very successful, all at a cost per boat that is some 85% less than we would face to buy a refurbished equivalent. We have also budgeted for the cost of some further asset purchases but will only commit to major expenditure when guaranteed additional income to pay for it has been secured.

Policy on Reserves

It is our policy to maintain a Strategic Reserve of not less than the total operational cost for a single year. In view of the uncertainty of demand for our services and client income we are holding a cautious position. This money will only be used in extreme circumstances where we cannot meet our operational costs through income or other funds.

Demand for our services continue to increase as we recover from the pandemic and with a cautious approach to finances we are confident of the long term viability of the charity.

Plans for the Coming Year


The plan for the 2023 season is to continue to rebuild both our client and volunteer numbers. We will look to establish or renew links with school groups where possible, building on the improved training structure.

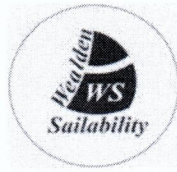
