WALES BY MAKING GRANTS OF MONEY FOR PROVIDING OR PAYING FOR ITEMS SERVICES OR FACILITIES.(III) TO PROMOTE AND PROTECT GOOD HEALTH THROUGH THE PROVISION OF FINANCIAL ASSISTANCE,INFORMATION, SUPPORT, EDUCATION AND ADVICE SO AS TO IMPROVE THE CONDITIONS OF LIFE.(IV) TO PROMOTE ANY OTHER EXCLUSIVELY CHARITABLE OBJECTS AND PURPOSES AS THE TRUSTEES SEE FIT,PROVIDED THAT THEY ARE REGARDED AS CHARITABLE BY THE LAW OF ENGLAND AND WALES.
