**Objects:** 3.1.1 TO PROVIDE OR ASSIST IN THE PROVISION OF FACILITIES AND SERVICES FOR RECREATIONAL, SPORTING OR OTHER LEISURE TIME OCCUPATION IN THE INTERESTS OF SOCIAL WELFARE, SUCH FACILITIES BEING PROVIDED TO THE PUBLIC AT LARGE SAVE THAT SPECIAL FACILITIES MAY BE PROVIDED FOR PERSONS WHO BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABILITY, POVERTY OR SOCIAL OR ECONOMIC CIRCUMSTANCES MAY HAVE BEEN OF SPECIAL FACILITIES AND SERVICES; AND/OR 3.1.2 THE ADVANCEMENT AND SUPPORT OF EDUCATION, CULTURE, ARTS, HERITAGE AND HISTORY INCLUDING THE PROVISION OF LIBRARIES, MUSEUMS, GALLERIES, LEARNING AND INFORMATION CENTRES, ARCHIVES AND OTHER RELATED SERVICES; AND/OR 3.1.3 TO PROMOTE COMMUNITY PARTICIPATION IN HEALTHY RECREATION; AND/OR 3.1.4 TO ADVANCE THE EDUCATION OF THE PUBLIC ON THE BENEFIT OF ACTIVE LIFESTYLE AND IN PARTICULAR THE VALUE OF PHYSICAL ACTIVITY FOR YOUNG PEOPLE; AND/OR 3.1.5 SUCH OTHER CHARITABLE PURPOSES BENEFICIAL TO THE COMMUNITY CONSISTENT WITH THE OBJECTS ABOVE AS THE TRUSTEES SHALL IN THEIR ABSOLUTE DISCRETION DETERMINE (THE "OBJECTS")
