REPORT OF THE TRUSTEES FOR THE PERIOD 1 AUGUST 2023 TO 31 JANUARY 2025

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the period 1 August 2023 to 31 January 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

INTO Giving supports a wide range of humanitarian and community causes whilst maintaining a special focus on education. The objectives of the Charity are:

- To advance the education of young people in particular, but not exclusively, girls and those living in impoverished circumstances, by making grants anywhere in the world;
- To act as a resource for young people providing advice and assistance and organising programmes of physical, educational and other activities as a means of advancing life and helping young people develop skills, capacities and capabilities that enable them to participate in society as independent, mature and responsible individuals;
- To advance such charitable purposes (according to the Law of England & Wales) for the public benefit, as the trustees see fit from time to time, through providing grants anywhere in the world that support the prevention or relief of poverty, the advancement of health, community development, human rights, environmental protection and improvement, science, amateur sport, the promotion of social diversity and harmony, the relief of those suffering disability and social, medical and financial disadvantage, the efficiency of fire, rescue and ambulance services, and to further such purposes as are recognisable as exclusively charitable under the Law of England and Wales.

For the period from 1 August 2023 to 31 January 2025, the Charity has been undergoing a period of review due to changes in funding, and consequentially there have been limited fundraising and donations during this period.

Activities

Total income of £101,077 was received during the year. Of this amount, £63,043 was donated by INTO University Partnerships to cover all costs of the remuneration and termination payments of the INTO Giving employees who left the business in August and September 2023.

The remaining £38,034 was received from donations, interest and other income.

A total £1,243 was donated to a number of charities including The Christie Charity and Bowel Cancer UK.

FINANCIAL REVIEW

Reserves policy

The Charity has, at 31 January 2025, unrestricted reserves amounting to £117,946 as shown on page 6 of these financial statements.

INTO Giving maintains restricted funds to facilitate strategic new initiatives in accordance with the Charity's mission and strategic plan. Restricted funds represent matched funding from the INTO Giving Founder, Andrew Colin. As at 31 January 2025, the Charity had restricted reserves of £85,924.

FINANCIAL REVIEW

Going concern

The Trustees have assessed the charity's ability to continue as a going concern.

At 31 January 2025, the Charity held cash and cash equivalents of £206,871, of which £85,924 was restricted and £120,947 was unrestricted. The Charity has no borrowings, no long-term liabilities, and only minimal recurring operating costs.

Given the very substantial level of unrestricted cash reserves, the complete absence of debt or financing obligations, and the low level of ongoing expenditure, the Trustees are satisfied that the unrestricted reserves are more than sufficient to meet all current and foreseeable commitments.

The Trustees therefore have a reasonable expectation that INTO Giving has adequate resources to continue in operational existence for the foreseeable future (being at least, but not limited to, the next 12 months from the date of approval of these financial statements).

Accordingly, the financial statements have been prepared on the going concern basis and the Trustees have concluded that there is no material uncertainty related to going concern.

FUTURE PLANS

To meet our commitment to supporting acutely disadvantaged schoolchildren, INTO Giving will, in 2025/26 continue to support education projects globally, despite the COVID-19-induced downturn in the Charity's income.

INTO Giving will continue to support our existing family of projects if required and where appropriate. All projects put forward will be put to the Trustees for consideration and selection.

This report has been prepared in accordance with the special provisions of Part 15 of the Companies Act 2006 relating to small companies.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Charity constitutes a Company limited by guarantee. The Directors are appointed and removed in accordance with the terms set out in the Company's Articles of Association. At least three Directors must be appointed at any one time, but there is no maximum to this number. There are currently eight Directors appointed to the Company, all of whom are Trustees of the Charity. A Chairperson is decided at each board meeting in the absences of an appointed Chairperson.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Statement of Trustees' Responsibilities

The Trustees are responsible for preparing the Trustees' annual report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company and charity law requires the Trustees to prepare financial statements for each financial year. Under company law the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the group and parent charity and of the incoming resources and application of resources, including its income and expenditure, of the group for the year. In preparing those financial statements the Trustees are required

to:

- Select suitable accounting policies and then apply them consistently
- Observe the methods and principles in the Charities SORP
- Make judgments and accounting estimates that are reasonable and prudent
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The Trustees are responsible for keeping adequate and proper accounting records that are sufficient to show and explain the Charity's transactions and disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Charities Act 2011 and regulations made thereafter and with the requirements of the Companies Act 2006. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In so far as the Trustees are aware:

- there is no relevant audit information of which the charitable company's auditors are unaware; and
- the trustees have taken all steps that they ought to have taken to make themselves.

New Trustees are inducted and their responsibilities are outlined to them so that they are aware of their accountabilities.

Organisational structure

Day-to-day management of the charity is delegated to the Trustees with operational support provided on a zero-cost basis by INTO University Partnerships colleagues. INTO Giving's board of trustees aim to meet regularly to assess the financial and strategic direction of the charity, and to provide advice toward achieving the charity's objectives. By majority vote, the board approves the charity's annual accounts and all of INTO Giving's restricted and unrestricted grant-making.

Risk management

The Trustees have a duty to identify and review the risks to which the Charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

The main risk to the Charity is ensuring that funds raised by employees of INTO University Partnerships (IUP), their related companies, families and friends, go direct to the charity and that no funds go astray. This is a particular risk when working with partner charities based abroad.

However, INTO Giving has put in place measures to ensure that, as far as possible, the monies raised are spent on the intended project. This is done by completing due diligence prior to establishing any relationship with partner charities and establishing close relationships with our partner charities, who provide clear sets of accounts to INTO Giving showing how our donations have been spent and the impact of these donations on beneficiaries. Partner charities provide regular feedback, and we request they be open to INTO Giving staff and supporters who wish to visit the project.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

The accounts are prepared on a going concern basis after consideration by the trustees that there are no material uncertainties about the Charity's ability to continue as a going concern. Such consideration includes a review of committed income and expenditures, cash flows and reserves. The trustees do not consider that there are any sources of estimation uncertainty at the reporting date that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next reporting period.

The accounts are presented in the companies functional currency of pound sterling (£). Monetary amounts in these financial statements are rounded to the nearest £1.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 July 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

INTO Giving supports a wide range of humanitarian and community causes whilst maintaining a special focus on education. The objectives of the Charity are:

- To advance the education of young people in particular, but not exclusively, girls and those living in impoverished circumstances, by making grants anywhere in the world;
- To act as a resource for young people providing advice and assistance and organising programmes of physical, educational and other activities as a means of advancing life and helping young people develop skills, capacities and capabilities that enable them to participate in society as independent, mature and responsible individuals;
- To advance such charitable purposes (according to the Law of England & Wales) for the public benefit, as the trustees see fit from time to time, through providing grants anywhere in the world that support the prevention or relief of poverty, the advancement of health, community development, human rights, environmental protection and improvement, science, amateur sport, the promotion of social diversity and harmony, the relief of those suffering disability and social, medical and financial disadvantage, the efficiency of fire, rescue and ambulance services, and to further such purposes as are recognisable as exclusively charitable under the Law of England and Wales.

The primary aims of the Charity are:

- To improve the well-being and future of disadvantaged young people through good quality education
- To create lasting change for disadvantaged young people
- To equip young people with greater confidence and skills

OBJECTIVES AND ACTIVITIES

The focus of our work

INTO Giving partners with other charities to provide and improve education for young people around the world living in difficult circumstances. In the period 1 August 2021 to 31 July 2022 INTO Giving has supported 24 charitable projects in 9 countries across 5 continents.

In 2019/20 we maintained a special focus on supporting girls' education in the developing world and refugee education. We continued investing in homelessness support, began supporting anti-sexual assault services, and responded to the Ukrainian refugee crisis. Our projects were:

YUM (Indonesia)

INTO Giving donated £5,000 to provide 170 schoolchildren in Cipanas, West Java with free afterschool tutoring and remedial lessons.

Children's Education Foundation (Vietnam)

With a £5,000 grant, INTO Giving is sponsoring the education of three schoolgirls

Children on the Edge (Lebanon)

INTO Giving's £5,000 grant is helping support the education of 270 Syrian refugee schoolchildren who have fled to Lebanon to escape their country's civil war.

Bumba (Uganda)

INTO Giving donated £1,000 towards classroom running costs for 87 primary schoolchildren.

Children Change (Colombia)

INTO Giving donated £3,000 toward help helping 650 children (59% girls) receive anti-sexual exploitation support

Venkat Trust (India)

INTO Giving donated £5,000 to sponsor girls from a poor, rural fishing village to go on to higher education

Building Blocks

INTO Giving donated £3,000 in support of fifteen primary schoolgirls' education and COVID-19 relief.

United Kingdom & USA

In 2021/22 INTO Giving, as part of its wider charitable remit to help a range of humanitarian and community causes, supported a host of organisations, including: Paiwand, Brighton Housing Trust and the US-based anti-sexual assault charity the Center for Community Solutions.

Strategic grants: girls' education and refugee support

INTO Giving, through £20,000 to Room to Read, continued supporting girls' education worldwide, and provided £13,834 to Save the Children Ukraine.

Student internships

In summer 2022, INTO Giving, together with its partner Room to Read, welcomed three international student interns, from Indonesia, Korea and Pakistan. INTO Giving supplied the interns' £6,832 expenses (accommodation, travel, food, and toiletries) in Brighton, London and San Francisco as they developed career-building work experience.

The internships were a long-held ambition, beginning in 2018/19, when INTO Giving elected to allocate a portion of its restricted reserves toward providing internships to international students. COVID-19 forced the cancellation of the internships in 2020 and again in 2021.

OBJECTIVES AND ACTIVITIES

Public Benefit

The Trustees have complied with their duty to have due regard to the guidance of the public benefit, published by the Charity Commission, in exercising their powers or duties by monitoring the quality of the provision of services funded by donations made by the Charity.

The Trustees review the fundraising activities and the projects they have supported at the end of the year and on a regular basis throughout the year. This review helps us to plan our future projects and fundraising activities and to adjust the plans accordingly. The review also helps us to ensure that we are planning our activities and selecting projects to meet the objectives as set out in the Memorandum of Association.

How our activities deliver public benefit

INTO Giving exists to serve the public, with a special emphasis on ensuring children, young people and others in need benefit from improved access to education and improved quality of education.

Our support for girls' education reduces the risk of girls being excluded from school and further education. To us, girls' education is a case of human and civil rights. Educated girls will marry later, have children later and their children will live longer and are more likely to be educated themselves.

INTO Giving's support for refugees helps ensure that children and young people who have lost their homes and communities continue to learn and, with support from school, rebuild a sense of normality and hope.

We support impoverished and at-risk children in Colombia, Guatemala, India, Indonesia, Lebanon, Nepal, Nigeria, Uganda, Vietnam and Zambia.

In communities in the UK and the US we support a range of activities, including mental health support, a domestic abuse shelter, young carers and anti-racism and civil rights.

ACHIEVEMENT AND PERFORMANCE

Raising awareness

INTO Giving is the charitable offshoot of INTO University Partnerships (IUP), which has more than 1,800 employees and, every year, more than 14,000 students from more than 100 countries across the world. The Charity strives to educate these audiences on the power of philanthropy, how it shapes people - particularly young people - as individuals, and how it shapes communities and global society. We raise awareness of our work and opportunities to engage in philanthropy through presentations at universities, IUP publications (in print and online), the charity's website and through social media. This has resulted in hundreds of young people and IUP staff shaping a better idea of philanthropy and engaging in activities that help some of the most disadvantaged children have access to and stay in education

Fundraising activities

A total of £184,979 was raised by INTO Giving in the financial year ending 31 July 2022 of which £128,606 was from INTO University Partnerships toward the charity's operating costs.

Fundraising events were also organised by INTO staff and students. All funds raised from these events go direct to our projects and not to INTO Giving operating costs. INTO Giving appreciates the hard work that has gone into the above fundraising and would like to thank all those who donated.

Impact of COVID-19

The coronavirus pandemic negatively impacted INTO Giving's income in 2019/20, 2020/21 and again in 2021/22, which, whilst seeing some modest gain on the previous year, is still down considerably compared to pre-pandemic

Despite this, INTO Giving maintained its commitments to supporting developing world education projects, particularly girls' education, whilst responding to the emerging crisis brought about by war in Ukraine.

Fund-raising activities' financial performance

This year we raised £184,979.

£104,790 has been spent on charitable purposes, including: £20,000 to each of Room to Read and Brighton Housing Trust; £13,800 to Save the Children Ukraine; £6,600 to the Centre for Community Solutions (US); £5,000 to each of Children on the Edge (Lebanon), YUM (Indonesia), Venkat Trust (India), and the Children's Education Foundation (Vietnam); £3,900 to Haisru Dala (India); £3,000 grants to each of Children Change Colombia and Building Blocks (India)

Grants of under £3,000 were made to organisations including: Bumba (Uganda), Paiwand, Walk the Walk, Refuge, and the Hummingbird Refugee Project

We have kept our costs to a minimum as follows:

Total costs, therefore, account for 8% of total funds raised in the year ending 31 July 2022. Of these costs, £14,254 (94%) was paid on behalf of INTO Giving by INTO University Partnerships (IUP) and is shown as a donation in these accounts. This resulted in the charity using only £980 of its own funds toward operating costs in financial year 2021/22

FINANCIAL REVIEW

Principal funding sources

The principal funding sources for the Charity come from INTO University Partnerships (IUP), fundraising activities carried out by IUP students and employees, associated partners and other related third parties. These funds are given in the form of individual donations through sponsoring events, payroll giving and donations from international students attending IUP courses.

The Charity ensures that all monies raised by the staff of IUP, associated partners, families and friends, the general public, companies and grant-making trusts go direct to our projects. Any costs incurred in the running of the Charity are paid for by INTO University Partnerships and Gift Aid collected on major donors' donations. INTO Giving is deeply grateful to IUP and our regular donors for their steadfast support during the COVID-19 pandemic.

Reserves policy

The Charity has, at 31 July 2022, unrestricted reserves amounting to £99,517 as shown on page 10 of these financial statements.

INTO Giving maintains restricted funds to facilitate strategic new initiatives in accordance with the Charity's mission and strategic plan. Restricted funds represent matched funding from the INTO Giving Founder, Andrew Colin. As at 31 July 2022, the Charity had restricted reserves of £117,979

During financial year 2021/22, INTO Giving continued providing educational sponsorship of orphans and vulnerable children cared for by the I-CCO in Zambia. The sponsorship donations are restricted funds and solely used to support the sponsored children. As at 31 July 2022, the Charity had utilised all of these restricted funds. This fund is replenished on a monthly basis by IUP staff and student regular donors.

FUTURE PLANS

To meet our commitment to supporting acutely disadvantaged schoolchildren, INTO Giving will, in 2022/23 continue to support education projects globally, despite the COVID-19-induced downturn in the Charity's income. We will seek to develop new income streams, as part of a new strategic plan.

INTO Giving will also continue to champion its iGive programme that supports a wide array of humanitarian and community projects, whilst maintaining our commitment to supporting education projects globally.

INTO Giving will continue to support our existing family of projects if required and where appropriate. All projects put forward will be put to the Trustees for consideration and selection.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Charity constitutes a Company limited by guarantee. The Directors are appointed and removed in accordance with the terms set out in the Company's Articles of Association. At least three Directors must be appointed at any one time, but there is no maximum to this number. There are currently nine Directors appointed to the Company, all of whom are Trustees of the Charity. A Chairperson is decided at each board meeting in the absences of an appointed Chairperson.

Trustees

All INTO Giving Trustees give their time voluntarily and receive no benefit from the Charity. The Trustees bring a wide and relevant range of experience to the Charity including work in education either at secondary or tertiary level and considerable business experience in the UK and abroad.

INTO University Partnerships (IUP) employees worldwide are offered the opportunity to apply to be a trustee. All trustee applications are assessed by the INTO Giving Director, and a member of the INTO University Partnerships HR team, using a common set of criteria. INTO Giving and INTO HR interview the shortlisted candidates. Those candidates who progress to the next round are interviewed a second time by the INTO Giving Director and two serving trustees. New trustees are offered an induction by the INTO Giving Director.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Organisational structure

Day-to-day management of the charity is delegated to the INTO Giving Director. The Director is responsible for financial decisions and control in line with the trustee-approved annual budget; implementing the annual workplan, covering fundraising, communications and administration; managing the INTO Giving team, including twice annual performance reviews; and preparing all papers for the board of trustees. The Director is supported by a team of 1.6 FTE employees who deliver a range of fundraising and communications functions and regular bank reconciliations. INTO Giving's board of trustees meet quarterly to assess the financial and strategic direction of the charity, and to provide advice toward achieving the charity's objectives. By majority vote, the board approves the charity's annual budget, annual accounts and all of INTO Giving's restricted and unrestricted grant-making.

Pay and remuneration of the charity's key personnel are in line with INTO University Partnerships (IUP) pay and remuneration policy: IUP provide all of the charity's operating costs, including salaries of the charity's team.

Risk management

The Trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

The main risk to the Charity is ensuring that funds raised by staff of INTO University Partnerships (IUP), their related companies, families and friends, go direct to the charity and that no funds go astray. This is a particular risk when working with partner charities based abroad. However, INTO Giving has put in place measures to ensure that, as far as possible, the monies raised are spent on the intended project. This is done by completing due diligence prior to establishing any relationship with partner charities and establishing close relationships with our partner charities, who provide clear sets of accounts to INTO Giving showing how our donations have been spent and the impact of these donations on beneficiaries. Partner charities provide regular feedback, and we request they be open to INTO Giving staff and supporters who wish to visit the project.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 July 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

INTO Giving supports a wide range of humanitarian and community causes whilst maintaining a special focus on education. The objectives of the Charity are:

- To advance the education of young people in particular, but not exclusively, of those living in impoverished circumstances, by making grants anywhere in the world;
- To act as a resource for young people providing advice and assistance and organising programmes of physical, educational and other activities as a means of advancing life and helping young people develop skills, capacities and capabilities that enable them to participate in society as independent, mature and responsible individuals;
- To advance such charitable purposes (according to the Law of England & Wales) for the public benefit, as the trustees see fit from time to time, through providing grants anywhere in the world that support the prevention or relief of poverty, the advancement of health, community development, human rights, environmental protection and improvement, science, amateur sport, the promotion of social diversity and harmony, the relief of those suffering disability and social, medical and financial disadvantage, the efficiency of fire, rescue and ambulance services, and to further such purposes as are recognisable as exclusively charitable under the Law of England and Wales.

The primary aims of the Charity are:

- To improve the well-being and future of disadvantaged young people through good quality education
- To create lasting change for disadvantaged young people
- To equip young people with greater confidence and skills

OBJECTIVES AND ACTIVITIES

The focus of our work

INTO Giving partners with other charities to provide and improve education for young people around the world living in difficult circumstances. In the period 1 August 2020 to 31 July 2021 INTO Giving has supported 18 charitable projects in 12 countries across 5 continents.

In 2019/20 we maintained a special focus on supporting girls' education in the developing world and refugee education. We began investing in civil rights and anti-racism projects, support for homelessness, and made grants in support of COVID-19 research and relief. Our project our projects were:

YUM (Indonesia)

INTO Giving donated £5,000 to provide 170 schoolchildren in Cipanas, West Java with free afterschool tutoring and remedial lessons.

Children's Education Foundation (Vietnam)

With a £5,000 grant, INTO Giving is sponsoring the education of three schoolgirls

Children on the Edge (Lebanon)

INTO Giving's £5,000 grant is helping support the education of 270 Syrian refugee schoolchildren who have fled to Lebanon to escape their country's civil war.

Bees Abroad (Nigeria)

INTO Giving, with a £2,000 donation is supporting secondary schoolchildren's environmental education. 60% of the students learning beekeeping are girls.

In-Community Care for Orphans (Zambia)

INTO Giving donated £960 in sponsorship of orphans and vulnerable children, many of whose parents have died or are suffering from HIV/Aids.

Malagiri School (Nepal)

INTO Giving donated £3,000 towards the school's annual running costs, including school meals for the more than 60 schoolchildren (more 60% of whom are girls).

Bumba (Uganda)

INTO Giving donated £3,000 towards classroom running costs for 87 primary schoolchildren.

Children Change (Colombia)

INTO Giving donated £3,000 toward help helping 650 children (59% girls) receive anti-sexual exploitation support

GLXi (Guatemala)

INTO Giving donated £3,000 toward a primary school literacy and teacher training programme.

Venkat Trust (India)

INTO Giving donated £6,200 to sponsor six girls from a poor, rural fishing village to go on to higher education and to provide COVID-19 relief.

Building Blocks

INTO Giving donated £3,000 in support of fifteen primary schoolgirls' education and COVID-19 relief.

United Kingdom & USA

Public Benefit

We support impoverished and at-risk children in Colombia, Guatemala, India, Indonesia, Lebanon, Nepal, Nigeria, Uganda, Vietnam and Zambia.

In communities in the UK and the US we support a range of activities, including mental health support, a domestic abuse shelter, young carers and anti-racism and civil rights.

Raising awareness

INTO Giving is the charitable offshoot of INTO University Partnerships (IUP), which has more than 1,800 employees and, every year, more than 14,000 students from more than 100 countries across the world. The Charity wants to educate these audiences on the power of philanthropy, how it shapes people - particularly young people - as individuals, and how it shapes communities and global society. We raise awareness of our work and opportunities to engage in philanthropy through presentations at universities, IUP publications (in print and online), the charity's website and through social media. This has resulted in hundreds of young people and IUP staff shaping a better idea of philanthropy and engaging in activities that help some of the most disadvantaged children have access to and stay in education.

Fundraising activities

A total of £163,109 was raised by INTO Giving in the financial year ending 31 July 2021 of which £123,101 was from INTO University Partnerships toward the charity's operating costs.

Fundraising events were also organised by INTO staff and students. All funds raised from these events go direct to our projects and not to INTO Giving operating costs. INTO Giving appreciates the hard work that has gone into the above fundraising and would like to thank all those who donated.

Impact of COVID-19

The coronavirus pandemic negatively impacted INTO Giving's income in 2020/21 and saw all but one of the INTO Giving team furloughed for the first quarter of the financial year.

Despite this, we began supporting three new education projects, continued supporting eight other education projects, continued investing in anti-racism and civil rights organisations and continued fundraising to ensure the future of our grant-making programmes

Fund-raising activities' financial performance

This year we raised £163,109.

£62,529 has been spent on charitable purposes: a total of £20,000 to the Runnymede Trust, Stop AAPI Hate and Color of Change; £6,200 to the Venkat Trust; £5,000 grants to each of Children on the Edge-Lebanon, Children's Education Foundation and YUM; £3,000 grants to each of the Malagiri School, Bumba Foundation, Children Change Colombia, Building Blocks and GLXi.

Grants of under £3,000 were made to half a dozen organisations including: Bees Abroad, MIND and Refuge.

We have kept our costs to a minimum as follows:

Total costs, therefore, account for 11% of total funds raised in the year ending 31 July 2021. Of these costs, £17,120 (94%) was paid on behalf of INTO Giving by INTO University Partnerships (IUP) and is shown as a donation in these accounts. This resulted in the charity using only £1,100 of its own funds toward operating costs in financial year 2020/21.

FINANCIAL REVIEW

Principal funding sources

The principal funding sources for the Charity come from fundraising activities carried out by INTO University Partnerships (IUP), IUP students and employees, associated partners and other related third parties. These funds are mostly given in the form of individual donations through sponsoring events, standing orders and donations from international students attending IUP courses.

The Charity ensures that all monies raised by the staff of IUP, associated partners, families and friends, the general public, companies and grant-making trusts go direct to our projects. Any costs incurred in the running of the Charity are paid for by INTO University Partnerships and Gift Aid collected on the Founder's matching donations. INTO Giving is deeply grateful to IUP and our regular donors for their steadfast support during the COVID-19 pandemic.

Reserves policy

The Charity has, at 31 July 2021, unrestricted reserves amounting to £98,629 as shown on page 10 of these financial statements.

INTO Giving maintains restricted funds to facilitate strategic new initiatives in accordance with the Charity's mission and strategic plan. Restricted funds represent matched funding from the INTO Giving Founder, Andrew Colin. As at 31 July 2021, the Charity had restricted reserves of £168,383

During financial year 2020/21, INTO Giving continued providing educational sponsorship of orphans and vulnerable children cared for by the I-CCO in Zambia. The sponsorship donations are restricted funds and solely used to support the sponsored children. As at 31 July 2021, the Charity had utilised all of these restricted funds. This fund is replenished on a monthly basis by IUP staff and student regular donors.

FUTURE PLANS

To meet our commitment to supporting acutely disadvantaged schoolchildren, INTO Giving will, in 2021/22 continue to support education projects globally, despite the COVID-19 downturn in the Charity's income. We will seek to develop new income streams, including an online merchandising facility.

INTO Giving will also continue to champion its iGive programme that supports a wide array of humanitarian and community projects, whilst maintaining our commitment to supporting education projects globally.

We will also continue our strategic partnerships programme, launched in 2020/21, seeing INTO Giving providing large grants to organisations working in the fields of anti-racism and civil rights.

INTO Giving will continue to support our existing family of projects if required and where appropriate. All projects put forward will be put to the Trustees for consideration and selection.

This report has been prepared in accordance with the special provisions of Part 15 of the Companies Act 2006 relating to small companies.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Charity constitutes a Company limited by guarantee. The Directors are appointed and removed in accordance with the terms set out in the Company's Articles of Association. At least three Directors must be appointed at any one time, but there is no maximum to this number. There are currently nine Directors appointed to the Company, all of whom are Trustees of the Charity. A Chairperson is decided at each board meeting in the absences of an appointed Chairperson.

Trustees

All INTO Giving Trustees give their time voluntarily and receive no benefit from the Charity. The Trustees bring a wide range and relevant range of experience to the Charity including: five who have worked in education either at secondary or tertiary level; two who have served as school Board of Governors; one who has worked overseas in Africa and five with considerable business experience in the UK and abroad.

INTO University Partnerships (IUP) employees worldwide are offered the opportunity to apply to be a trustee. All trustee applications are assessed by the INTO Giving Director, and a member of the INTO University Partnerships HR team, using a common set of criteria. INTO Giving and INTO HR interview the shortlisted candidates. Those candidates who progress to the next round are interviewed a second time by the INTO Giving Director and two serving trustees. New trustees are offered an induction by the INTO Giving Director.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Organisational structure

Day-to-day management of the charity is delegated to the INTO Giving Director. The Director is responsible for financial decisions and control in line with the trustee-approved annual budget; implementing the annual workplan, covering fundraising, communications and administration; managing the INTO Giving team, including twice annual performance reviews; and preparing all papers for the board of trustees. The Director is supported by a team of 1.6 FTE employees who deliver a range of fundraising and communications functions and regular bank reconciliations. INTO Giving's board of trustees meet quarterly to assess the financial and strategic direction of the charity, and to provide advice toward achieving the charity's objectives. By majority vote, the board approves the charity's annual budget, annual accounts and all of INTO Giving's restricted and unrestricted grant-making.

Pay and remuneration of the charity's key personnel are in line with INTO University Partnerships (IUP) pay and remuneration policy: IUP provide all of the charity's operating costs, including salaries of the charity's team.

Risk management

The Trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

The main risk to which the Charity is subject to is that of ensuring that funds raised by staff of INTO University Partnerships (IUP), their related companies, families and friends, go direct to the charity and that no funds go astray. This is a particular risk when working with partner charities based abroad. However, INTO Giving has put in place measures to ensure that, as far as possible, the monies raised are spent on the intended project. This is done by completing due diligence prior to establishing any relationship with partner charities and establishing close relationships with our partner charities, who provide clear sets of accounts to INTO Giving showing how our donations have been spent and the impact of these donations on beneficiaries. Partner charities provide regular feedback, and we request they be open to INTO Giving staff and supporters who wish to visit the project.

We will also continue our strategic partnerships programme, launched in 2019/20, seeing INTO Giving providing large, multi-year grants to partner organisations working in the fields of education and homelessness.

INTO Giving will continue to support our existing family of projects if required and where appropriate. All projects put forward will be put to the Trustees for consideration and selection.

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

11. RELATED PARTY DISCLOSURES

During the year, INTO University Partnerships financed £123,101 of the charity's operating costs, including salaries of the charity's team (2020, £129,899). This amount is therefore showing within income as a donation, as well as within expenditure in the financial statements.

12. POST BALANCE SHEET EVENTS

Prior to the balance sheet date there was an outbreak of the COVID-19 virus reaching the level of a global pandemic as defined by the World Health Organisation (WHO).

The effect of UK Government measures to limit the spread of the virus have been widespread, urging people to remain at home wherever possible, including to work from home if available and to undertake "social distancing" measures. Part of the government action has been to order businesses where people gather socially to close temporarily.

Whilst the Charity remained open throughout the pandemic, its employees worked remotely from their homes from mid-March 2020, and members of the Charity team were furloughed for the first quarter of the 2020/21 financial year, as part of the UK Government job retention scheme.

In respect of the current COVID 19 situation the Charity has reviewed its business. Despite the temporary and at times significant downturn in income, and with the patronage of INTO University Partnerships, who provide the Charity's operating costs, INTO Giving remains a going concern. The directors continue to monitor the situation as it changes and will react to further developments.

13. ULTIMATE CONTROLLING PARTY

Into Giving Limited is controlled by the Board of Trustees.

14. COMPANY LIMITED BY GUARANTEE

The company is a private company, limited by guarantee and consequently does not have share capital. Each of the Trustees is liable to contribute an amount not exceeding £10 towards the assets of the company in the event of a liquidation.

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 July 2020. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

INTO Giving supports a wide range of humanitarian and community causes whilst maintaining a special focus on education.

The objectives of the Charity are:

- To advance the education of young people in particular, but not exclusively, of those living in impoverished circumstances, by making grants anywhere in the world;
- To act as a resource for young people providing advice and assistance and organising programmes of physical, educational and other activities as a means of advancing life and helping young people develop skills, capacities and capabilities that enable them to participate in society as independent, mature and responsible individuals;
- To advance such charitable purposes (according to the Law of England & Wales) for the public benefit, as the trustees see fit from time to time, through providing grants anywhere in the world that support the prevention or relief of poverty, the advancement of health, community development, human rights, environmental protection and improvement, science, amateur sport, the promotion of social diversity and harmony, the relief of those suffering disability and social, medical and financial disadvantage, the efficiency of fire, rescue and ambulance services, and to further such purposes as are recognisable as exclusively charitable under the Law of England and Wales.

The primary aims of the Charity are:

- To improve the well-being and future of disadvantaged young people through good quality education
- To create lasting change for disadvantaged young people
- To equip young people with greater confidence and skills

OBJECTIVES AND ACTIVITIES

The focus of our work

INTO Giving partners with other charities to provide and improve education for young people around the world living in difficult circumstances. In the period 1 August 2019 to 31 July 2020 INTO Giving has supported 43 charitable projects in more than 25 countries across 5 continents.

In 2019/20 we maintained a special focus on supporting girls' education in the developing world and refugee education. We began investing in civil rights and anti-racism projects, support for homelessness, and made grants in support of COVID-19 research and relief. Our project our projects were:

Room to Read

INTO Giving is supporting girls' education with a donation of £40,000 toward mentoring and literacy programmes in ten countries

Bees Abroad (Nigeria)

INTO Giving, with a £2,549 donation is supporting secondary schoolchildren's environmental education. 60% of the students learning beekeeping are girls.

Peter M Goodrich Foundation (Afghanistan)

With a donation of £5,000, INTO Giving supported four scholarship programmes for schoolchildren aged 7-17 and an additional £1,000 in COVID-19 relief.

In-Community Care for Orphans (Zambia)

INTO Giving donated £1,020 in sponsorship of orphans and vulnerable children, many of whose parents have died or are suffering from HIV/Aids.

Jusoor (Lebanon)

INTO Giving donated £1,500 to the costs of a teacher working with 50 children at the tented refugee settlement in the Bekaa Valley.

Malagiri School (Nepal)

INTO Giving donated £5,000 towards the school's annual running costs, including school meals for the more than 60 schoolchildren (more 60% of whom are girls).

Bumba (Uganda)

INTO Giving donated £6,000 towards classroom running costs for 87 primary schoolchildren and an additional £1,000 in COVID-19 relief

Umbwi (Malawi)

INTO Giving donated £5,000 toward building a dormitory for 240 secondary schoolgirls.

Children Change (Colombia)

INTO Giving donated £7,500 toward help helping 650 children (59% girls) receive anti-sexual exploitation support

GLXi (Guatemala)

INTO Giving donated £7,500 toward a primary school literacy and teacher training programme.

Venkat Trust (India)

INTO Giving donated £7,500 to sponsor six girls from a poor, rural fishing village to go on to higher education and an additional £1,000 in COVID-19 relief

Building Blocks

INTO Giving donated £7,500 in support of fifteen primary schoolgirls' education and COVID-19 relief

United Kingdom & USA

In 2018/19 INTO Giving, as part of its expanded charitable remit to help a range of humanitarian and community causes, supported a host of organisations, including: Crisis, YMCA Norfolk, Walk the Walk, Downsview School, Lauren McClusky Foundation, Action against Hunger, Casa de Salud, Alzheimer's Society and Allsorts.

Strategic grants: anti-racism and homelessness

INTO Giving, through donations totaling £16,000, drawn from both our restricted and unrestricted reserves, is supporting anti-racism and civil rights work through donations to Color of Change and the NAACP (USA) and Stop Hate UK.

We also supported 80 women at a homeless project with a £25,000 donation to Brighton Housing Trust, and donated £25,000 to provide 10,000 meals to homeless people, low-income families and women's refuges through FareShare Sussex.

COVID-19 grants

In addition to the coronavirus relief grants listed above, INTO Giving donated £25,000 toward COVID-19 research and relief with grants to the WHO, British Red Cross, Feeding America, Give2Asia and Fixed Star.

Raising awareness

INTO Giving is the charitable offshoot of INTO University Partnerships (IUP), which has more than 1,800 employees and, every year, more than 14,000 students from more than 100 countries across the world. The Charity wants to educate these audiences on the power of philanthropy, how it shapes people - particularly young people - as individuals, and how it shapes communities and global society. We raise awareness of our work and opportunities to engage in philanthropy through presentations at universities, IUP publications (in print and online), the charity's website and through social media. This has resulted in hundreds of young people and IUP staff shaping a better idea of philanthropy and engaging in activities that help some of the most disadvantaged children have access to and stay in education.

ACHIEVEMENT AND PERFORMANCE

Fundraising activities

A total of £214,827 was raised by INTO Giving in the financial year ending 31 July 2020 of which £129,899 was from INTO University Partnerships toward the charity's operating costs.

Impact of COVID-19

The coronavirus pandemic negatively impacted INTO Giving's income over the final five months of the financial year and saw all but one of the INTO Giving team furloughed for the remainder of financial year 2019/20.

Despite this, INTO Giving stepped up its charitable giving, for the first time donating more than £200,000 (nearly doubling 2018/19 donations), including to organisations providing COVID-19 research and emergency relief.

Fund-raising activities' financial performance

This year we raised £214,827.

£211,272 has been spent on charitable purposes: £40,000 to Room to Read, £25,000 to each of Brighton Housing Trust and FareShare Sussex, £8,500 to each of Venkat Trust and Children Change Colombia, £7,500 to Building Blocks, £7,000 to Bumba Foundation, £6,700 to each of Stop Hate UK and the NAACP, £6,000 to Goodrich Foundation, £5,588 to Fixed Star, £5,000 to each of the Malagiri School, Umbwi, the WHO, Feeding America, British Red Cross, YMCA Norfolk and Give2Asia.

Grants of under £5,000 were made to 25 organisations including: Bees Abroad, Walk the Walk, Color of Change, Jusoor, Kelly Hendry School, Crisis, Oakley School, Allsorts, Foundation of Goodness, Alzheimcr's Society, West End Foodbank, Radio Lollipop, WWF, ICCO, PRIMA, Buddy Bag and Hope Through Action.

We have kept our costs to a minimum as follows:

Total costs, therefore, account for 15% of total funds raised in the year ending 31 July 2020. Of these costs, £29,188 (91%) was paid on behalf of INTO Giving by INTO University Partnerships (IUP) and is shown as a donation in these accounts. This resulted in the charity using only £3,035 of its own funds toward operating costs in financial year 2019/20.

FINANCIAL REVIEW

Principal funding sources

The principal funding sources for the Charity come from fundraising activities carried out by INTO University Partnerships (IUP), IUP students and employees, associated partners and other related third parties. These funds are mostly given in the form of individual donations through sponsoring events, standing orders and donations from international students attending IUP courses.

The Charity ensures that all monies raised by the staff of IUP, associated partners, families and friends, the general public, companies and grant-making trusts go direct to our projects. Any costs incurred in the running of the Charity are paid for by INTO University Partnerships and Gift Aid collected on the Founder's matching donations. INTO Giving is deeply grateful to IUP and our regular donors for their steadfast support during the COVID-19 pandemic.

Reserves policy

The Charity has, at 31 July 2020, unrestricted reserves amounting to £105,119 as shown on page 9 of these financial statements.

INTO Giving maintains restricted funds to facilitate strategic new initiatives in accordance with the Charity's mission and strategic plan. Restricted funds represent matched funding from the INTO Giving Founder, Andrew Colin. As at 31 July 2020, the Charity had restricted reserves of £197,061.

During financial year 2019/20, INTO Giving continued providing educational sponsorship of orphans and vulnerable children cared for by the I-CCO in Zambia. The sponsorship donations are restricted funds and solely used to support the sponsored children. As at 31 July 2020, the Charity had utilised all of these restricted funds. This fund is replenished on a monthly basis by IUP staff and student regular donors.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Charity constitutes a Company limited by guarantee. The Directors are appointed and removed in accordance with the terms set out in the Company's Articles of Association. At least three Directors must be appointed at any one time, but there is no maximum to this number. There are currently nine Directors appointed to the Company, all of whom are Trustees of the Charity. A Chairperson is decided at each board meeting in the absences of an appointed Chairperson.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Trustees

All INTO Giving Trustees give their time voluntarily and receive no benefit from the Charity. The Trustees bring a wide range and relevant range of experience to the Charity including: five who have worked in education either at secondary or tertiary level; two who have served as school Board of Governors; one who has worked overseas in Africa and five with considerable business experience in the UK and abroad.

INTO University Partnerships (IUP) employees worldwide are offered the opportunity to apply to be a trustee. All trustee applications are assessed by the INTO Giving Director, and a member of the INTO University Partnerships HR team, using a common set of criteria. INTO Giving and INTO HR interview the shortlisted candidates. Those candidates who progress to the next round are interviewed a second time by the INTO Giving Director and two serving trustees. New trustees are offered an induction by the INTO Giving Director.

Organisational structure

Day-to-day management of the charity is delegated to the INTO Giving Director. The Director is responsible for financial decisions and control in line with the trustee-approved annual budget; implementing the annual workplan, covering fundraising, communications and administration; managing the INTO Giving team, including twice annual performance reviews; and preparing all papers for the board of trustees. The Director is supported by a team of 1.6 FTE employees who deliver a range of fundraising and communications functions and regular bank reconciliations. INTO Giving's board of trustees meet quarterly to assess the financial and strategic direction of the charity, and to provide advice toward achieving the charity's objectives. By majority vote, the board approves the charity's annual budget, annual accounts and all of INTO Giving's restricted and unrestricted grant-making.

Pay and remuneration of the charity's key personnel are in line with INTO University Partnerships (IUP) pay and remuneration policy: IUP provide all of the charity's operating costs, including salaries of the charity's team.

Risk management

The Trustees have a duty to identify and review the risks to which the charity is exposed and to insure appropriate controls are in place to provide reasonable assurance against fraud and error.

The main risk to which the Charity is subject to is that of ensuring that funds raised by staff of INTO University Partnerships (IUP), their related companies, families and friends, go direct to the charity and that no funds go astray. This is a particular risk when working with partner charities based abroad.

However, INTO Giving has put in place measures to ensure that, as far as possible, the monies raised are spent on the intended project. This is done by completing due diligence prior to establishing any relationship with partner charities and establishing a close relationships with our partner charities, who provide clear sets of accounts to INTO Giving showing how our donations have been spent and the impact of these donations on beneficiaries. Partner charities provide regular feedback, and we request they be open to INTO Giving staff and supporters who wish to visit the project

PUBLIC BENEFIT

The Trustees have complied with their duty to have due regard to the guidance of the public benefit, published by the Charity Commission, in exercising their powers or duties by monitoring the quality of the provision of services funded by donations made by the Charity.

The Trustees review the fundraising activities and the projects they have supported at the end of the year and on a regular basis throughout the year. This review helps us to plan our future projects and fundraising activities and to adjust the plans accordingly. The review also helps us to ensure that we are planning our activities and selecting projects to meet the objectives as set out in the Memorandum of Association.

How our activities deliver public benefit

INTO Giving exists to serve the public, with a special emphasis on ensuring children, young people and others in need benefit from improved access to education and improved quality of education.

Our support for girls' education reduces the risk of girls being excluded from school and further education. To us, girls' education is a case of human and civil rights. Educated girls will marry later, have children later and their children will live longer and are more likely to be educated themselves.

INTO Giving's support for refugees helps ensure that children and young people who have lost their communities in the UK and the US we support a range of activities, including local schools, medical care and research, homeless projects and hospices. Their homes and communities continue to learn and, with support from school, rebuild a sense of normality and hope.

We support impoverished and at-risk children in and from Afghanistan, Colombia, Guatemala, India, Lebanon, Malawi, Nepal, Nigeria, Uganda, the UK and US and Zambia.

In communities in the UK and the US we support a range of activities, including local schools, medical care and research, homeless projects and support for carers.

Future Plans

To meet our commitment to supporting acutely disadvantaged schoolchildren, INTO Giving will, in 2020/21 continue to support education projects globally, despite the COVID-19 downturn in the Charity's income. We will seek to develop new income streams, including an online merchandising facility.

INTO Giving will also continue to champion its iGive programme that supports a wide array of humanitarian and community projects, whilst maintaining our commitment to supporting education projects globally.

We will also continue our strategic partnerships programme, launched in 2019/20, seeing INTO Giving providing large, multi-year grants to partner organisations working in the fields of education and homelessness.

INTO Giving will continue to support our existing family of projects if required and where appropriate. All projects put forward will be put to the Trustees for consideration and selection.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

Transfers between funds

During the year £9,837 was received for various projects, during the year an amount of £19,173 was spent on these projects and is included in restricted expenditure, at the year-end £9,336 was transferred from general funds to unrestricted funds in order to cover all the expenditure related to these projects.

11. RELATED PARTY DISCLOSURES

During the year, INTO University Partnerships provided all of the charity's operating costs, including salaries of the charity's team, £129,899 (2019: £110,604). This amount is therefore showing within income as a donation, as well as within expenditure in the financial statements

12. POST BALANCE SHEET EVENTS

Prior to both the balance sheet date to the approval of these accounts an outbreak of the COVID-19 virus occurred causing a global pandemic recognised by the World Health Organisation (WHO).

The effect of UK Government measures to limit the spread of the virus have been widespread, urging people to remain at home wherever possible, including to work from home if available and to undertake "social distancing" measures. Part of the government action has been to order businesses where people gather socially to close temporarily.

Whilst the Charity remained open throughout the pandemic, its employees worked remotely from their homes from mid-March 2020, and members of the Charity team were furloughed between May and November 2020, as part of the UK Government job retention scheme.

In respect of the current COVID 19 situation the Charity has reviewed its business. Despite the temporary and at times significant downturn in income, and with the patronage of INTO University Partnerships, who provide the Charity's operating costs, INTO Giving remains a going concern through calendar years 2021. The directors continue to monitor the situation as it changes and will react to further developments.

13. ULTIMATE CONTROLLING PARTY

Into Giving Limited is controlled by the Board of Trustees.

14. COMPANY LIMITED BY GUARANTEE

The company is a private company, limited by guarantee and consequently does not have share capital. Each of the Trustees is liable to contribute an amount not exceeding £10 towards the assets of the company in the event of a liquidation.
