Our income is still down .We have had two open days and a camping event .By pure bad luck the weather was so bad on these events that we received only half of the normal amount. In addition we are being hit by the cost of living crisis and a lot of our regular donors have either reduced the amount they give or stopped it altogether. This is causing significant difficulties and we are reducing the number of animals we can take in as a result.

We have continued to rehome animals with virtual homechecks taking the place of visits to prospective homes. This was due to covid and continues.
