THE TRUSTEES MAY RELIEVE SUCH PERSONS BY:THE PROVISION OF HOUSING UPON TERMS APPROPRIATE TO THEIR MEANS; OR MAKING GRANTS OF MONEY TO THEM; OR PROVIDING OR PAYING FOR GOODS, SERVICES OR FACILITIES FOR THEM, INCLUDING PAYMENTS TOWARDS THE PROVISION OF HOUSING ACCOMMODATION; OR MAKING GRANTS OF MONEY TO OTHER PERSONS OR BODIES WHO PROVIDE GOODS, SERVICES OR FACILITIES TO THOSE IN NEED.

**Activities:** The object of the charity is the relief of persons who are in need, hardship or distress who are resident in the area of benefit. The charity provides relief by the provision of housing upon terms appropriate to their means, in three cottages owned by the charity in Exford, Somerset.
