STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charity governing document is a constitution that was adopted 21st September 2008. The Charity is governed by a Board on which the trustees are represented. It meets regularly to review, plan activities and monitor the financial position.

OBJECTIVES AND ACTIVITIES

The objective of the organisation is to advance the Christian faith and to relieve poverty by promoting the youth and their development within and outside the church through various skills, activities and spreading the gospel of Christ to all, irrespective of race and nationality. The trustees confirm that they have had due regard to the guidance issued by the Charity Commission on public benefits before deciding what activities the charity should undertake.

ACHIEVEMENTS AND PERFORMANCE

The Organisation held successful conferences and convention through the year in which individuals were equipped and educated on the principles and doctrines of the Christian faith. It continues to support missionary work in various places.

FINANCIAL REVIEW

The income of the Charity is **£202,824.83** which in **£150,000.00** placement (one year fixed deposit in the bank). This is a good amount for the Charity, but compare to the income in year ended 2022 of £182,015.15. Costs have been well managed over this period. The charity has used a lot of its resources to cover the costs for rent, welfare services, conventions and transportation.

RESERVE POLICY

It is the policy of the Charity to maintain unrestricted funds, which are the reserves of the charity at about 3 months of unrestricted expenditure. This provides sufficient funds to cover any emergency expenditure that may arise from time to time. The charity will seek to maintain this level throughout the year.

RISK MANAGEMENT

The Charity have assessed all the major risks to which the charity is exposed to, in particular those related to operations and finances of the charity, and are satisfied that systems are in place to mitigate exposure to major risks.

TRUSTEE RESPONSIBILITIES

Under the charity Act 1993, the trustees are required to prepare a statement of accounts for each accounting year which gives a true and fair view of the state of the church. They are required to:

- 1 Select suitable accounting policies and apply them consistently.
- 2 Make judgements and estimates that are reasonable and prudent.
- 3 State whether the applicable accounting standards have been followed.
- 4 Prepare financial statements on on-going basis.

They are responsible for keeping proper records which disclose with reasonable accuracy the finances of the church at any time and to ensure that such accounts comply with the Charity Act 1993. They also have a responsibility to safeguard the assets of the church and to take reasonable steps to detect fraud or other irregularities.

To the Trustees

Respective responsibilities of trustees and examiner

NOTES TO THE FINANCIAL STATEMENT FOR THE YEAR ENDED 31ST DECEMBER, 2023.

ACCOUNTING POLICIES

Basis of Accounting

These accounts have been prepared on the receipts and payments basis under section 42(3) of the Charities Acts 1993.

FUNDS

Unrestricted funds are those which can be used at the Trustees' discretion. Restricted funds are those whose purposes have been restricted by the donor. The cash fund at the end of the year 2023 of £202,824.83 included £150,000.00 fixed deposit in Natwest Bank.

Trustees Remuneration

No trustee received remuneration during the financial year.
