Objects: THE TRUSTEES MUST APPLY THE INCOME OF THE CHARITY IN FURTHERING THE FOLLOWING OBJECTS ("THE OBJECTS"):TO ADVANCE IN LIFE AND HELP CHILDREN AND YOUNG PEOPLE THROUGH:(A) THE PROVISION OF RECREATIONAL AND LEISURE TIME ACTIVITIES PROVIDED IN THE INTEREST OF SOCIAL WELFARE, DESIGNED TO IMPROVE THEIR CONDITIONS OF LIFE;(B) THE PROVISION OF SUPPORT AND ACTIVITIES, WITH A CHRISTIAN ETHOS, WHICH DEVELOP THEIR SKILLS, CAPACITIES, CAPABILITIES AND FAITH, TO ENABLE THEM TO PARTICIPATE IN SOCIETY AS MATURE AND RESPONSIBLE INDIVIDUALS;(C) THE PROVISION OF FINANCIAL AND OTHER SUPPORT FOR ACTIVITIES SUCH AS REFERRED TO IN THE PRECEDING SUB-CLAUSES OF THIS CLAUSE 3.FOR THESE PURPOSES, THOSE AGED BETWEEN 11 AND 21 SHOULD BE CLASSED AS "YOUNG PEOPLE", WHILE YOUNGER AGE GROUPS SHOULD BE CLASSED AS "CHILDREN."
