C) SUPPORTING THE DEVELOPMENT AND PROVISION OF RESOURCE CENTRES FOR THE DIAGNOSIS AND TREATMENT OF CANCER IN TEENAGERS AND YOUNG ADULTS.3. TO PROVIDE AND ASSIST IN THE PROVISION OF EQUIPMENT, FACILITIES AND SERVICES TO YOUTH ORGANISATIONS WITHIN THE WINCHESTER & ROMSEY AREA.
