Activities: The Trust has ensured the safekeeping of funds raised by Abingdon Town Amateur Boxing Club for shared community sports facilities. The Trust began distributing funds for sport in Abingdon in 2021/22. In September 2022 the boxing club was relaunched and the trust helped the relaunch. Plans are now progressing for a new sports hall and the trust will consider using funds for that purpose.
