Activities: The Trust is active in disbursing small grants for ecological purposes generally totalling up to £10,000 per annum. These are primarily for smallscale projects in the Woolhope Dome area of England but the trustees will also consider applications from a broader geographical area if these fit with the objectives of the trust.
