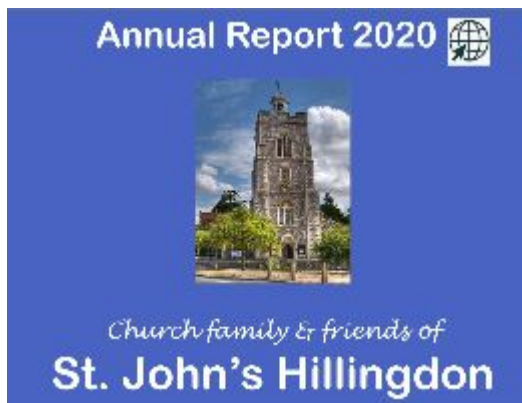

Dear Friends & Members of St. John's

Unusually, it is only 6 months since I last wrote my annual report! Strange that, due to the delay in our Annual General Meeting last year as a result of coronavirus, our AGMs have ended up being only half a year apart!

As I write this, the whole world continues to go through hard, sad and trying times due to the pandemic. In the UK we are currently coming out of our third lockdown in stages, and non-essential shops have opened this week. The vaccination programme is going well, cases and

deaths have dropped, and there is optimism that we will be returning to a new normal in the next few months. We are still working out what this all means for us moving forward as a worshipping community, both in-person and online .

We have continued to meet online using 'Zoom' for Sunday morning services and this has enabled many of us to be together for worship and to interact with one another. We have now had a year's worth of such services; numbers attending have been consistent and encouraging. There have also been a good number who haven't been able to join us due to not having the internet, or for other reasons, and we have endeavoured to keep connected in a variety of ways. We have also had good numbers (compared to in-person) for our Wednesday morning Zoom prayer and study sessions. Unfortunately we have not been able to meet as 'Elevate Church' for over a year due to the virus. The 'Rooted in Love' book formed the basis of our Lent course and reflections, and we encouraged everyone to get the book. The course and reflections went very well. The Online Link has continued to be sent out every week, and this has been much appreciated.

As you probably are all aware, we are facing challenges with the deterioration of the building due to its age and condition. We started to address these problems intentionally following the appointment of our new Architect, Alex Veal. Since our 'big' meeting in the summer of 2019 with the Archdeacon, Alex and the Diocesan Advisory Council, which assists and advises on church buildings, we have been 'at it' and we are making progress. We have a plan and I am keen that we play a 'high pressing' game so that we can gain momentum and fulfill our vision.

Thanks to a successful £24k grant bid, and to generous gifts (thank you members), the cupola was stabilised last winter and this will 'buy us' up to five years in order to see to a permanent repair. Three of the six main support posts have failed and there is numerous areas of decay. Unfortunately a further problem developed with falling stones and masonry which presented us with a significant safety problem at the front of the building. At the time of writing we have heard that we have been successful with another grant application, for £16k, to help with re-opening costs, and with the possibility of using some of this towards repairing the buttress flint work.

The Wardens, PCC and I have been working on a holistic strategy so that we can get the church building repaired, and also develop a constant improvement plan for the building and the grounds. I'm introducing to you here our "4 Pillar and Churchyard Gardens" strategy:



You can see from the diagram above that the four pillars are 'Vision & Need', 'External', 'Internal' and 'Grants & Finances'. The fifth area is the churchyard/garden areas. A lot of work is presently going into planning and getting together specifications for various works throughout. We continue to make forward movement in each section, although there are some stubborn areas that remain 'on hold' due to lack of finances, or grant opportunities, such as the leaky Grundon Room, which is now dry again thanks to the coordination and efforts of Churchwarden Rick. We have still managed to meet fairly frequently as a PCC, thanks to technology. On the PCC we have discussed the possibility of the building not only being a place of Christian worship, but also a centre of well-being which builds on the incredible heritage that we have and also incorporates the Arts. More will be shared about our building and plans at the forthcoming AGM.

Financially, 2020 was difficult due to losses of income due to the building having to be shut. This reduced our income from collections in church, hires and the occasional offices. Our income was £12-15k down on the previous year, although we had a positive balance for the year of some £10k, but this was only because we reduced the amount we usually pay to the Diocese known as Common Fund.

We continue to encourage, and be encouraged by, our 'home grown' ordinand-in-training, Caroline Reed. Thank you for the time we have spent together, Caroline, and for your care and leadership. I have also enjoyed working with our fab Administrator Nikki, and with David and Rick our Churchwardens. Thank you for your teamwork and for your work for God at St. John's. David is retiring from being Churchwarden after 20 years of serving! That's an amazing innings, David, and praise God for your willingness and dedication to St. John's as Warden over all the years. I also want to thank personally, and on behalf of everyone, our treasurer Carol Toombs who is retiring after 13 years of dedication to the role! We are so grateful for your service, Carol. I also want to thank Anne, my wife, for her support and for all she does for the church and community. Thank you to EVERYONE for all your contributions and for what you do to serve in the body of Christ in and through your connection with St. John's. (There are too many names to mention, so please count yourself thanked!)

It was sad to say goodbye in November to Carol Turner who went to be with God. Carol was a member of St. John's for so many years and served the church and community faithfully. We miss her, although we realise that she has moved to a better place. It was wonderful to see so many at the drive past for Carol outside St. John's, and at the prayers afterwards that took place in the Memorial Gardens.

As a community of church members and friends I want to encourage you to keep loving, growing and sharing with Jesus so that we can transform lives.

Churchwardens *Rick Williams & David Durston*

It goes without saying that 2020 was a year without precedent. Although it began in the normal way, the closure of all churches and national lockdown in March altered everything. As a result, the planned changes to encourage increased attendances at St John's had to be put on hold. Other initiatives, such as Elevate Church at St Andrews Park, were also mothballed – to be revived when circumstances permit. It is hoped this can take place during 2021.

Both churchwardens have been working with, and supporting, Alan in devising ways to give spiritual guidance to the congregation during this difficult period. The use of technology, to provide weekly Sunday worship and weekly prayer meetings, has proved to be a success. We must thank Alan for being the driving force behind this significant change in our worship at St John's.

A number of other individuals have contributed to our online services – in particular thanks must go to Daniel for providing weekly IT assistance to Alan, with Anne, Alice and Beth all helping out

at various times. Andrew and Paul are due thanks for providing musical support to our revised worship services, as are the team who have preached or led throughout the year.

Most of the usual activities undertaken by your churchwardens have had to be suspended during 2020. Despite that, both Churchwardens have attended PCC meetings during the year, both in person and via zoom, after the introduction of the first lockdown in March. These meetings have enabled the continued administration of St Johns.

Rick continues with his responsibilities for the maintenance and upkeep of the church fabric and our three residential properties. Regular reports have been presented to the PCC which, once again, confirm the poor condition of the fabric of St Johns. Our retained architect is in the process of preparing a forward repair strategy for the next few years.

Stabilising work to the timber cupola on top of the tower was completed in early December, following a substantial grant from Heritage England towards the cost of this repair. Repairs to the defective flint work to the face of the tower are now required for health and safety reasons. These are being costed.

Due to the work required to the cupola the outstanding repairs to the Grundon Room roof are still to be progressed, but funding will be an issue. Work to the cedar tree in the churchyard was completed in March, but further attention is required following more branches falling during high winds.

Your churchwardens are confident that the inherent strength within the St John's family will enable it to weather the current situation and to move forward once normality is restored.

Carol Williams Commissioned Minister

With the change of services from in person to via Zoom (thank you internet) it has been a year totally unlike any other since I was first commissioned. I have faced the initially daunting task of having to preach on line – and therefore being able to see myself while I spoke. This was a fairly unsettling experience to start with, but along with the rest of the preaching team who have taken part during the last twelve months, it has become easier with practice!

In addition to the preaching slot at the Sunday morning service, I also led a couple of the Wednesday morning prayer meetings – which is something I would not normally do if we were not in the current situation. This has been a whole new experience for me and shows that you can always find something new to learn! Along with the rest of the St John's family, I am of course hoping that we will be able to physically be together again in the not too distant future!

Richard Bell Children's Safeguarding Officer

The PCC have once again approved my role as an 'appropriately experienced' Parish Safeguarding Officer at St John's.

The PCC recently agreed to adopt and implement the House of Bishops' Safeguarding Policy 'Promoting a Safer Church' and as such approved the St John's Safeguarding Policy Statement for 2021 which is available on our website.

I have conducted and reported upon the annual safeguarding audit to the diocese and PCC with no immediate actions.

Safeguarding is a fixed agenda item and I regularly provide written updates at each PCC meeting. I am always available to attend in person if requested.

The PCC have received a specific awareness session on its safeguarding responsibilities.

I can confirm all persons that have direct contact with children have the appropriate checks and safeguarding training in place and we continue to ensure these are all updated.

Once we are able to open the church I will continue to monitor and review all church activities to assess and address any identified safeguarding issues immediately and always make myself available to provide advice to Alan, The Churchwardens and the PCC when required.

I'd like to thank Lucy our Children's Champion for her continued support, I will be working closely with Lucy as we look to improve everyone's understanding of what safeguarding means.

Deanery Synod Keith Lunn

Many churches across Hillingdon managed to upgrade their online presence during 2020, by live-streaming or recording services and keeping in contact by video and phone, for example in study groups, and many report increases in the numbers reached. Some opened their premises when allowed even if only for individual prayer. The Deanery Synod, with representatives from Church of England parishes across Hillingdon, gathered before the lockdown and set in motion aspects of an ambitious new Deanery Plan, which includes the closure and merging of some churches but also new church initiatives, for example in the Cowley Peachey area, and a new workplace chaplaincy for Stockley Park. The plan has made a very promising start with the arrival of a new minister at St Anselm's in Hayes, where a previously dwindling congregation has already doubled since coming out of lockdown and a major refurbishment has started. Other new signs of life are new clergy in Uxbridge, Ickenham and Eastcote. A new Diocesan Strategy will encourage parishes to develop new initiatives in the fields of environmental action, slavery and refugees, mental health and financial well-being, youth violence and homelessness, while improving their culture and practice on racial justice, safer churches and youth engagement. The Diocesan strategy encourages a 'culture shift towards everyday faith' and a focus on greater lay involvement, discipleship and wider and deeper growth.

Groups & Church Activities

Bellringers Captains Report Michael J Palmer.

REPORT for 2020 by CAPTAIN of the BELLRINGERS GUILD

Since lockdown started, we have kept in touch with weekly "Zoom" sessions at our normal practice times. After a general discussion about how we were doing and current events, we started to use a simulator software programme called ringingroom.com. This had been developed for remote ringing over the internet. We found that using this successfully required new skills, persistence and patience. As a band we have made considerable progress doing this from when we began using this tool nearly a year ago.

In July, tower bell ringing restrictions were lifted and after a safety survey had been carried out at each tower we rang at, to ensure it was possible to ring with a gap of about two metres between ringers. We also wore face masks, used hand gel sanitiser and rang for about 15 minutes only. With permission from the incumbents, when possible, we rang at St Andrew's Uxbridge, Hayes, Harlington and Iver on Sundays for morning service and Wednesdays for practices. In general only 4 ringers could ring at each tower so this meant we could ring simultaneously at more than one tower at a time. We found ringing 4 bells successfully was not easy so we refreshed our "Back to basics" training on bell handling and generally improved striking.

We were not able to ring at Hillingdon during this time because of work to the cupola, tower and church, still ongoing.

Unfortunately, we had to stop tower ringing again in September but we continued our "Zoom" sessions on practice nights and I hope these will be ongoing until restrictions are lifted. At times our ringing here is very good.

Our social events this year have been restricted to two afternoon visits to The Hut in Colham Green.

Thanks to all who have supported this year, especially a big thank you to Bob who has made just about all the arrangements for our events, both ringing and social.

The Eco Group Report. *Christine Bartlett, Chris Rodrigues, Brenda Thomas and Lynn Clark.*

During 2020, climate change was high on the agenda for governments and will continue to be so. Plastic pollution, deforestation and global warming are subjects that affect us all and our actions and buying choices in turn have an effect on those things, it's like great big vicious circle. The Eco Group continue to do all we can to bring this to everyone's attention and it is our hope and prayer that we will **all** do our bit to make a difference.

In the autumn, we took part in various online zoom meetings and conferences concerning the target set by the General Synod of the Church of England for every church, office and Church of England school to be zero carbon by 2030. This will be a huge challenge for everyone but it is not impossible. The Eco Group plan to help and support the PCC in achieving this for St John's.

An important development which took place in 2020 was the formation of The Eco Action Group. Chris Rodrigues is our representative on this group and she explains here what it's all about.

2020 saw the introduction of the Eco Action Group, an initiative put forward by members of the Willesden Diocese to encourage churches to sign up for the Eco Church Award scheme.

The Eco Group were invited to take part in the planning. I represented St Johns Eco Group in meetings held on zoom and took part in an inset training day for clergy.

The inset day was led by Andrew Ramsey with Ruth Valerio and Dave Bookless. I led a breakout room to talk about our journey at St Johns as an Eco group and how we gained an Eco church award. The initiative is ongoing, providing support for local churches. We can help at St Johns by giving encouragement and support, sharing our experiences as an Eco Church.

The highlight of 2020 for us was our Eco service held in the churchyard. Brenda Thomas recalls this event: *Three words that stood out were LISTEN, LEARN AND LOVE. Over the past months we've all been much more able to have time to appreciate God's creation, above us and all around us, and to **listen** to the sounds of nature in our gardens and on our walks. we have **learnt** about the effects that lockdown has had on the environment and how nature has flourished with less harmful emissions. We can **learn** together about the changes we need to make to our own lives,*

*There have been overwhelming acts of **love** and caring in our communities. We have the **love** of*

*each other and of family and friends to support us as we change our habits, find new ways of living and most importantly we have the **love** of God.*

The Churchyard *Christine Bartlett*

During 2020, the churchyard came into its own as a haven for all of us. Without the sanctuary of the church building, closed because of coronavirus and building issues, the churchyard has been a place for people to visit and find a holy space for prayer, reflection and relaxation.

During the lockdown periods, the churchyard team has not been able to work together but we have been working individually at different times as part of our daily exercise allowance. In spite of this we have been able to sow grass seed to a large swathe of the northside, bulbs have been planted near the cross on the south side, and several areas are now dedicated to wild flowers. Additionally, some the monuments previously fenced off with "danger signs" displayed have now been made safe.

During the summer, we realised that people were spending time around the garden of remembrance and so we added prayer boards, which we change regularly to reflect the seasons, festivals, and global prayer needs.

Another project that has been flourishing during 2020 is historic research on the people buried in the churchyard and in vaults under the church floor. Mark and Helen Hamlin are putting together a spreadsheet with all of the information that we are finding out about them from online resources. It is hoped that as soon as we are able there will be a programme of walks and talks based on our findings.

In 2021, an arborist is coming to inspect the trees. In preparation for this the trees were counted and we were amazed to find there are 95! Also in 2021, the limes trees will be pollarded and we are very grateful to Hillingdon Borough Council who have granted us funds to pay for this work to be done.

Finally, a note about our poor cedar tree which sheds branches at an alarming rate. In the near future, another branch which hangs over the road is going to be removed as well as the very large and heavy cones which are weighing down the remaining branches. It will be interesting to see what the arborist has to say about it!

In the last 30* days, we have had 1,544* views from 634 users and 606 new users. The most views were on the home page with 1,080*, that's 70%. Next was 'Church News' with 114* views, that's 7.4%.

Over the last year, we have had 10,010* views. Again the most views were on the home page with 5,409*, that's 54%. 'Church News' had 763* views, that's 7.6%. 'Sunday Services' had 522 views, that's 5.2%.

St John's is also on 'A Church Near You'. This website is a Church of England digital communication national resource hub.

We have had 79* views this week, 513* views this month, and 5,278* views this year.

ZOOM

When the coronavirus pandemic caused the first lockdown, we started using Zoom for our 10:30am service on Sunday mornings and for mid-week prayer at 10am on Wednesday mornings. Zoom has allowed us to still be interactive in our services and to have opportunities to socialise in the after service breakout rooms.

Other services and events have been held via zoom, such as our VE Day Afternoon Tea, memorial services, our Christingle and Christmas services. We also had our Ash Wednesday service, the Lent Course, and the Maundy Thursday 'Last Supper Experience' via zoom.

Zoom has enabled us to continue to meet together each week whilst our building has been closed for critical safety repairs. It has also meant that others who would be unable to physically join us, are able to still worship, pray and meet with us.

Zoom can be accessed via the internet from a computer, laptop, tablet or smart phone. It can also be accessed via a landline telephone.

We have now had 53 services on zoom, and have an average attendance of 74.31.

We have had 8 services in the memorial Garden, with an average attendance of 24.2.

During Lent, we used the book 'Rooted In Love' by our Diocese Bishops. Again this was on zoom, on Wednesday mornings and we had an average attendance of 26.5.

We are enriched by these times of still being able to be together as a family especially on our Sunday mornings. Worshipping together and then chatting together in breakout rooms has strengthened our church family. We are very grateful to those who help some of older members in joining in each week.

HOLY WEEK & EASTER *Anne Bradford*

With the coronavirus pandemic causing a national lockdown in March 2020, we were unable to have 'The Last Supper Experience' or 'The Watch' on Maundy Thursday, or on Good Friday the Churches Together in Long Lane joint service and Walk of Witness or the afternoon 'Journey to the Cross'.

Holy Week and Easter 2020 were a quieter time of more personal reflection.

In Holy Week 2021 as restrictions were starting to slightly ease from another national lockdown, we marked these special days by meeting together on zoom and in the church grounds. On Maundy Thursday, we shared 'The Last Supper Experience' together via zoom, followed by a personal quiet time for 'The Watch' in our own homes and gardens. This has been a strange and difficult year with the COVID situation and the church being closed for most of 2020 and still closed. Fortunately, we have been able to keep contact with St John's Church through the use of Zoom which enabled Alan, our vicar, to provide services for the congregation throughout the lock-down period and still ongoing.

As members of the PCC you consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

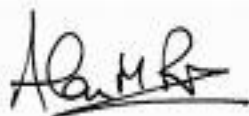
