### **Objects and activities of the charity**

#### ***The purposes of the charity as set out in its governing document.***

The principal activity of the charity is:

- 1) To provide or assist in the provision of facilities for their advancement of education and in the interests of social welfare for recreation or other leisure time activities of (principally) young people who have need of such facilities by reason of their youth, age, infirmity or disability, financial hardship or social circumstances with the object of improving their conditions of life.
- 2) To relieve poverty, sickness and distress and to advance education for the benefit of people in Somaliland (No activities taken in Somalia during the year) and the somali community in the UK.

#### ***The main activities undertaken in relation to those purposes during the year.***

East Africa Welfare and Development Association (EWADA) has delivered various activities for the people of East Africa. EWADA has carrying out variety of different mini and major projects including an ongoing project of a school, sponsoring orphans, Qurbani meat distribution, emergency food.

#### **The main achievements and performance of the charity during the year.**

Following are the projects conducted during the year:-

Teaching at orphans' School:

As usual, Hufaz (students) were supported towards their studies during the year.

Qurbani Project:

This year, EWADA once again carried out its Qurbani project, in collaboration with charity partners, to distribute fresh meat to some of the poorest individuals—many of whom rarely have the opportunity to eat meat. For some, this is the only time in the entire year they are able to enjoy it. As in previous years, EWADA ensured that meat was distributed to underprivileged families across various regions of Somaliland.

Water Project:

Nearly every year, Somaliland faces severe drought, leading to the tragic loss of lives due to lack of access to clean water. Since its inception, EWADA has made it a priority to provide safe drinking water to those in greatest need. To ensure sustainable access, the charity has been actively involved in drilling deep water boreholes—specialised wells that tap into underground water sources. In addition to constructing new boreholes, EWADA also maintains previously established ones to keep them functional and continue serving the communities that rely on them. EWADA operates its own fleet of water delivery trucks, which are used daily to distribute free water to people living in remote and underserved areas. Beneficiaries of this essential service include schools, hospitals, and mosques. In regions where the water table is not too deep, EWADA also digs wells and tube wells to provide a more permanent water solution for local communities.

Food Project:

EWADA operates a year-round food project, with a special focus during the holy month of Ramadan. This initiative supports both the general public and orphaned students enrolled in boarding schools, ensuring they receive regular and nutritious meals.

#### ***The difference the charity's performance during the year has made to the beneficiaries of the charity.***

Due to the ongoing drought, harsh weather conditions, and economic hardship—which have led to the loss of livestock, limited farming opportunities, and widespread displacement—many families have become internally displaced (IDPs), malnourished, and vulnerable. In response, EWADA has continued its vital support by providing food and water to affected households throughout the year.

As always, we have reached a significant number of beneficiaries across various regions, offering essential supplies such as food, clean water, meat, and clothing—especially during the holy months of Ramadan and Hajj (Qurbani).

Our ongoing educational project for orphans also continues to thrive, offering both secular and religious education to support and empower the younger generation in Somaliland.

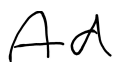
### Method of preparation of accounts - Small company provisions

### **Report of the Independent Examiner to the Trustees of the charitable company on the accounts for the year ended 30 June 2024**

I report to the Trustees on my examination of the financial statements of the charitable company on pages 9 to 21 for the year ended 30 June 2024 which have been prepared in accordance with the Charities Act 2011 (the Act) and with the Financial Reporting Standard 102, (effective 1st January 2016) as modified by FRS 102 SORP (Statement of Recommended Practice for Accounting and Reporting by Charities) 2015, (as amended by the Bulletin issued in February 2016), (The SORP), published by the Charity Commission in England & Wales (CCEW), and under the historical cost convention and the accounting policies set out on page 14.

#### **Respective responsibilities of the Trustees and the Independent Examiner and the basis of the report**

As described on page 5, you, the charitable company's Trustees, who are also the Directors of the Company for the purposes of Company law, are responsible for the preparation of the financial statements in accordance with the Companies Act 2006, the Charities Act 2011 and all other applicable law and with United Kingdom Generally Accepted Accounting Practice, applicable to smaller entities, and for being satisfied that the financial statements give a true and fair view.

The Trustees consider that the audit requirement of Section 144(1) of the Charities Act 2011 (the Act) does not apply, and that there is no requirement in the memorandum and articles of the charity for the conducting of an audit, and that the accounts do not require an audit in accordance with Part 16 of the Companies Act 2006 and that no member or members have requested an audit pursuant to Section 476 of the Companies Act 2006. As a consequence, the Trustees have elected that the financial statements be subject to independent examination.

Having satisfied myself that the financial statements are not required to be audited under any legal provision, or otherwise, and are eligible for independent examination, it is my responsibility to:-

- a) examine the financial statements of the charity under Section 145 of the Act;
- b) follow the applicable procedures in the Directions given by the Charity Commission under section 145(5)(b) of the Act.

#### **Basis of Independent Examiner's Statement and scope of work undertaken**

I report in respect of my examination of the charity's financial statements carried out under s145 of the Act. In carrying out my examination, I have followed all the applicable Directions given by the Charity Commission under section 145(5)(b) of the Act setting out the duties of an independent examiner in relation to the conducting of an independent examination. An independent examination includes a review of the accounting records kept by the charitable company and of the accounting systems employed by the charitable company and a comparison of the financial statements presented with those records. It also includes consideration of any unusual items or disclosures in the financial statements, and seeking explanations from you, as Trustees, concerning such matters. The purpose of the examination is to establish as far as possible that there have been no breaches of charity legislation and that, on a test basis of evidence relevant to the amounts and disclosures made, the financial statements comply with the SORP.

### 1 Accounting policies

#### *Policies relating to the production of the accounts.*

##### **Basis of preparation and accounting convention**

The accounts have been prepared on the accruals basis, under the historical cost convention, and in accordance with the Financial Reporting Standard 102, (effective 1st January 2016) and 'FRS 102 SORP (Statement of Recommended Practice for Accounting and Reporting by Charities) 2015, (as amended by the Bulletin issued in February 2016), (The SORP), published by the Charity Commission in England & Wales (CCEW) , effective January 2016, , and in accordance with all applicable law in the charity's jurisdiction of registration, except that the charity has prepared the financial statements in accordance with the FRS 102 SORP (Statement of Recommended Practice for Accounting and Reporting by Charities) 2015, (as amended by the Bulletin issued in February 2016), (The SORP), in preference to the previous SORP, the SORP 2005, which has been withdrawn, notwithstanding the fact that the extant statutory regulations, the Charities (Accounts and Reports) Regulations 2008 refer explicitly to the SORP 2005. This has been done to accord with current best practice.

##### **Risks and future assumptions**

The charity is a public benefit entity.

Value Added Tax is not recoverable by the charity, and is therefore included in the relevant costs in the Statement of Financial Activities.

If upon winding up or dissolution of the charity there remain any assets, after the satisfaction of all debts and liabilities, the assets represented by the accumulated fund shall be transferred to some other charitable body or bodies having similar objects to the charity.
