DURING THE PERIOD, THE CHARTY SECURED INCOME OF £58,759 AND EXPENDED £52,135 OF WHICH GRANTS WERE £29,647 AND EVENT COSTS WERE £20,015. THIS RESULTED IN A SURPLUS OF £9,874 WHICH WERE ADDED TO PRIOR YEAR SURPLUSES GIVING THE TOTAL SURPLUSES AS £53,590. THE TRUSTEES HAVE A POLICY NOT TO HOLD ANY RESERVES APART FROM FUNDS THAT ARE COMMITTED FOR FUTURE CHARITABLE AND ADMINSTRATIVE EXPENDITURE.

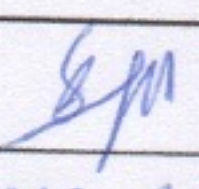

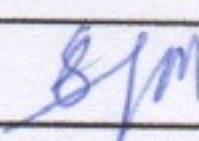
