REPORT OF THE TRUSTEES
for the year ended 31st October 2023

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31st October 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

Our memorandum of Association states:

"The charity's objects are 1. To advance the Christian religion for the benefit of the public by teaching, holding public services of worship, and producing and distributing literature to enlighten others about Christianity. 2. To relieve need, hardship, and physical and mental distress among all persons without limitation."

As a church we are grateful to God for His kindness and faithfulness to us. Here is a summary of our encouragements, blessings and challenges at October 2023.

Congregation and Session (Leadership)

We continue our weekly public meetings on Sunday morning, open to anyone in the community, where we gather for worship, instruction in the Christian faith, and extended time for informal discussion over refreshments, fellowship and a shared lunch. We have been glad to welcome a steady stream of visitors and new people, across a wide range of ages and cultural backgrounds.

We have a stable and committed leadership of three elders and an assistant pastor, and this has shown itself in the way we have been able to work together as a session. The congregation has grown gradually with the new people being local people. Our midweek bible study has been very well attended as we meet in two groups.

We have reached the final stages of joining a UK presbyterian denomination, which we hope to complete in 2024.

Outreach

1. **Door to Door** visiting of the local neighbourhood has enabled us to get to know local people and their needs.
2. **Street Carols.** Outdoor street carol singing has been a very effective way to gather larger numbers of neighbours for singing and a short presentation.
3. **The Easter Feast** is a great opportunity to invite new people to church.
4. **Big Questions.** This is a talk and discussion on a Sunday evening in a local pub. We have addressed big questions, where members invite friends along. This is advertised by the pub and on social media.

"Raising Expectations" Conference.

We were greatly encouraged by our conference attendance this year (130 attendees), and our speaker was Dr. Matthew Mason, along with Pr. Steve Hayhow.

Young People

We have begun a monthly teenager's meeting, which along with Chelmsford Presbyterian Church we joined a weekend away at Easter 2023. In addition we are developing a new collaboration with Chelmsford for The 18-30s group gathering people from a range of churches.

Oak Hill Student Placement.

We have two student placement from Oak Hill Theological College. A family who are preparing to become missionaries and are with us for another year whilst they train. We also have a young woman who is training for church work. It is a privilege to support them and their participation in the church and training.

Women's Ministry

A ladies meeting has begun and one of our older women is in the process of completing the biblical counselling training at BCUK.

FINANCIAL REVIEW

Principal funding sources

The main sources of income derive from donations of members and supporters. Donations for the year increased to £98,383 (compared to £64,781 in 2022) and total resources expended were £86,872 (compared to £71,661 in 2022).

Reserves policy

The Unrestricted Fund represents the free reserves of the charity. The Unrestricted Fund balance was £59,408 at 31st October 2023, providing the ability to have sensible buffer to cover fluctuations in giving and to start to build a fund to expand our work in the coming years. The restricted fund represents the reserves available to assist those in financial difficulty due to COVID. The Restricted Fund balance was £2,000 at 31st October 2023.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Our memorandum of Association states:

"The charity's objects are 1. To advance the Christian religion for the benefit of the public by teaching, holding public services of worship, and producing and distributing literature to enlighten others about Christianity. 2. To relieve need, hardship, and physical and mental distress among all persons without limitation."

Emmanuel Evangelical Church is organised as a limited company.

New trustees are appointed or stand down by trustee vote, which is recorded in the minutes. New trustees have been selected due to their relationship to the congregation, or that is they are regular worshippers at an evangelical church and of good character.

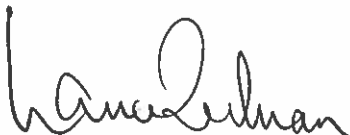

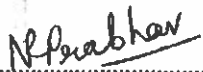

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.
