Activities

Objects: THE CHARITY'S OBJECTS (THE "OBJECTS") ARE THE PROMOTION OF THE EDUCATION OF THE CHILDREN OF COMMERCIAL TRAVELLERS, WITH A PREFERENCE FOR CHILDREN WHO HAVE NOT ATTAINED THE AGE OF TWENTY-FIVE YEARS, AND PRIMARILY OF THE DESTITUTE ORPHANS OF DECEASED AND THE CHILDREN OF NECESSITOUS COMMERCIAL TRAVELLERS ("BENEFICIARIES") IN ONE OR MORE OF THE FOLLOWING WAYS: (I) IN AWARDING THE BENEFICIARIES EXHIBITIONS, BURSARIES, MAINTENANCE ALLOWANCES OR GRANTS TENABLE AT ANY SCHOOL, UNIVERSITY, COLLEGE OF EDUCATION OR OTHER PLACE OF LEARNING APPROVED BY THE BOARD OF TRUSTEES; (II) IN PROVIDING FINANCIAL ASSISTANCE, OUTFITS, CLOTHING, TOOLS, INSTRUMENTS OR BOOKS TO HELP BENEFICIARIES ON LEAVING SCHOOL, UNIVERSITY OR OTHER EDUCATIONAL ESTABLISHMENT TO PREPARE FOR, OR TO ASSIST THEIR ENTRY INTO, A PROFESSION, TRADE OR CALLING; (III) IN AWARDING SCHOLARSHIPS, OR MAINTENANCE ALLOWANCES TO ASSIST BENEFICIARIES TO TRAVEL, WHETHER IN THIS COUNTRY OR ABROAD, IN ORDER TO FURTHER THEIR EDUCATION; (IV) IN PROVIDING FINANCIAL ASSISTANCE TO ENABLE BENEFICIARIES TO STUDY MUSIC OR OTHER ARTS; AND (V) IN OTHERWISE PROMOTING THE EDUCATION (INCLUDING SOCIAL AND PHYSICAL TRAINING) OF BENEFICIARIES.

Activities: Grants awarded to help with the education of the sons and daughters of commercial travellers, sales representatives and manufacturers' agents, where the family has suffered adversity, for children at

state, private day or boarding schools, college or university. A parent must have travelled to sell to the trade or business, not direct to the public. Children usually aged between 4 to 25.
