THE TRUSTEES SHALL PAY OR APPLY OR CAUSE TO BE APPLIED AT SUCH TIME OR TIMES AND IN SUCH MANNER AS THE TRUSTEES SHALL IN THEIR DISCRETION THINK FIT THE INCOME AND IF AND IN SO FAR AS THE TRUSTEES SHALL THINK FIT THE CAPITAL OF THE CHARITY IN PROMOTING THE OBJECTS.
