REPORT OF THE TRUSTEES
FOR THE YEAR ENDED 31 MARCH 2025

The Trustees present their Annual Report for the year ended 31 March 2025.

1. The Tristenagh Trust, which is registered in the Register of Charities under number 1128530, was established by Lieutenant Colonel A C Ford KCVO by a Trust Deed dated 10 March 2009.
2. The address of the Trust is 1 College Hill, London EC4R 2RA.
3. The Trustees are Lieutenant Colonel Sir Andrew Ford GCVO, Mrs R M Ford, Mr E C Ford and Mr T W Ford, who was appointed on 4 July 2024.
4. The Trust's bankers are Cater Allen.
5. The Trust was established for general charitable purposes. In practice, the income is distributed amongst a wide variety of charitable organisations spread throughout the United Kingdom. The Trustees confirm that they have had regard to the guidance on public benefit issued by the Charity Commission when considering the objectives and activities of the Trust.
6. The Trustees meet from time to time to review the position and to decide on grants.
7. In the period ended 31 March 2025, the Trust's income, before expenses, amounted to £37,320 (2024: £5,300). The sum of £32,020 was added to The Tristenagh Trust from a CAF account held in the name of Mrs RM Ford. Grants of £4,655 were made (2024: £4,929).
8. During the year, several grants were awarded to local and national UK charities.
9. At the year end the assets of the Trust amounted to £41,277 (2024: £8,912). There are never any significant liabilities and therefore the Trustees consider that they do not require a reserves policy.

Independent examiner's report to the Trustees of The Tristenagh Trust

I report on the accounts of the Trust for the year ended 31 March 2025, which are set out on the attached page and have been prepared on a receipts and payments basis.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011. The charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed. It is my responsibility to examine the accounts under section 145 of the 2011 Act, to follow the procedures laid down in the General Directions given by the Charity Commission under section 145(5)(b) of the 2011 Act, and to state whether particular matters have come to my attention.

Basis of independent examiner's report

My examination was carried out in accordance with General Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a "true and fair view" and the report is limited to those matters set out in the statement below.

Independent examiner's statement


