Objects: THE CHARITY'S OBJECTS (THE OBJECTS) ARE:(1) TO ADVANCE THE EDUCATION OF THE PUBLIC IN ANY PART OF THE WORLD WHO ARE THE VICTIMS OF WAR, NATURAL DISASTER, TROUBLE, CATASTROPHE OR POVERTY BY BUILDING SCHOOLS AND OTHERWISE PROVIDING AND ASSISTING IN THE PROVISION OF FACILITIES FOR EDUCATION.(2) THE RELIEF OF FINANCIAL NEED AND SUFFERING AMONG VICTIMS OF POVERTY OR NATURAL DISASTER OR OTHER KIND OF DISASTER, IN ANY PART OF THE WORLD, IN THE FORM OF MONEY (OR OTHER MEANS DEEMED SUITABLE, INCLUDING THE PROVISION OF MEDICAL AID) FOR PERSONS, BODIES, ORGANISATIONS AND/OR COUNTRIES AFFECTED.(3) THE RELIEF OF FINANCIAL HARDSHIP, EITHER GENERALLY OR INDIVIDUALLY, OF PEOPLE LIVING IN ANY PART OF THE WORLD BY MAKING GRANTS OF MONEY FOR PROVIDING OR PAYING FOR ITEMS SERVICES OR FACILITIES.(4) THE RELIEF OF THE SICK AND POOR LIVING IN ANY PART OF THE WORLD EITHER GENERALLY OR INDIVIDUALLY THROUGH THE PROVISION OF GRANTS, GOODS OR SERVICES(5) THE RELIEF OF SICKNESS AND THE PRESERVATION OF HEALTH AMONG PEOPLE RESIDING PERMANENTLY OR TEMPORARILY IN ANY AREA OF THE WORLD WHO ARE VICTIMS OF WAR, NATURAL DISASTER, TROUBLE, CATASTROPHE OR POVERTY.
