Activities: In Belize, the charity offers support and advice to young people, aged 18 and over, who have been brought up in the care system. In France, the charity offers affordable inner city homes to those in need by, amongst other things, offering a discounted refurbishment service to participating landlords in return for reduced rents for tenants meeting agreed acceptance criteria.
