OBJECTS

The Church is governed by the CIO Charity Constitution adopted on 21st November 2019 and Church Constitution dated May 2009 and updated on 21st November 2019, to reflect the change to a CIO, the principal objects for the benefit of the public being:

To relieve those in need by reason of youth, age, ill health, disability, financial hardship or other disadvantage and to promote and preserve good health, by the provision of funds, goods or services of any kind, including through the provision of counselling and support in such parts of the United Kingdom or the world, as the Trustees from time to time may think fit.
3. To advance education in such ways and in such parts of the United Kingdom or the world as the Trustees from time to time think fit.

These objects are exactly the same in both the CIO and Church Constitutions.

Simon Davidson assumed responsibility from Tim Verrall as both Acting Chairman and Acting Secretary, effective 15/12/22

Mat Martin's appointment was necessary since the Constitution requires two of the Trustees to be Church Elders.

RESPONSIBILITIES OF THE BOARD OF DIRECTORS:

Law applicable to charities in England and Wales requires that the Trustees prepare financial statements giving a true and fair view of the charity's financial activities during the year and of its financial position at the end of the year. In preparing financial statements, the Trustees should follow best practice and:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- follow applicable accounting standards without any material departures; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The Trustees are responsible for keeping accounting records, which disclose, with reasonable accuracy, the financial position of the charity, enabling them to ascertain that the financial statements comply with Charity Law, the Charity and Church Constitutions. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

RESERVES POLICY:

The Trustees have adopted a reserves policy, which they consider appropriate to enable the company to meet its developing commitments and obligations. To this end, the policy is to retain funds equivalent to approximately 2 months staff and administration costs.

PUBLIC BENEFIT STATEMENT:

The Trustees confirm that, when exercising their powers and duties, they have complied with the duty in Section 17 of the Charities Act 2011 to have due regard to Charity Commission's general guidance on public benefit.

REVIEW OF THE YEAR:

We start this report by thanking and honouring Tim Verrall for the commitment and enthusiasm he brought to the position of Trustee over many years. Tim finally 'retired' in December 2022 from role of Trustee, although remains as one of the Elders.

In October 2022, we transitioned the position of Treasurer from Jonathon Fewtser to Rod Martin. We recognise the commitment that Jonathon brought to the role but understand his desire to step down after almost 10 years in post. As is mandated in our M&As; Rod is a church member.

In March 2023, Martin Cooling resigned from his paid position of Senior Pastor; citing personal reasons and some differences of opinion that he could not reconcile with the other leaders.

Most of the Trustee activity for this reporting period, related to supporting the Eldership in re-establishing in person gatherings, (not just on Sundays) as COVID19 restrictions eased and were replaced by best practice recommendations.

As the use of Hope Christian Centre increased for mid-week meetings, it became more apparent that the building needed some attention with specific regards to:

- Exploratory drains work to ascertain cause of the 'smell'
- Plastering downstairs room – survey has confirmed the issue was caused by a leak from the upstairs kitchen which although repaired, caused 'salts' to seep out of the plaster and this is now needs to be treated by a specialist company.
- New handrail for Fire Escape Stairs (this has been completed in July 2023)

It was agreed we would complete the works that satisfy our Health & Safety obligations first and also produced a list of small works which will also need to be prioritised and costed. We are still looking to appoint a Premises Deacon to support us in their obligations to maintain and improve Hope Christian Centre building; the position would primarily involve the coordination of works to be undertaken. In the interim Phil Chorley and Simon Davidson are coordinating the activities.

As the Hope Community Church Hyde was served notice on its use of the old Argos space, Clarendon Square, Hyde; we needed to make alternative plans for a space to meet in on a Sunday and maintain a presence in the town mid-week. We were offered and accepted the use of the old Shoe Zone space, Clarendon Square, Hyde. From a Trustee perspective this required us to sign a legally binding Tenancy Agreement; witnessed by an appointed Solicitor who completed this as a pro bono piece of work.

FUTURE DEVELOPMENTS:

We believe that, although the financial year 2022/23 has been a challenging time for our fellowship, it has reminded us, even more, how dependent upon God we are and how He has plans to grow and prosper us as individuals and together. We will continue to strive to manage the Charity that is Hope Community Church (Tameside & Glossop) more effectively, to enable the people that are Hope Community Church and our wider communities the freedom to achieve their full God given potential. It reminds us that we need to continue to -

- Increasingly engage with the local community in a variety of ways.
- To always proclaim, as well as demonstrate, the love of God.
- Strive to live in such a way as to pursue:
 - Honour for Christ
 - Health for His Church
 - Hope for our Community
- Continue to strengthen relationships with other Churches in the local area.
- Manage the Charity that is Hope Community Church (Tameside & Glossop) more effectively, to enable the people that are Hope Community Church the freedom to achieve the above aims.
